

Re-Survey of Guy R. and Charlene French Lands in Part of Lot 3, in Quarter Township 3, Monroe Township, Muskingum County, Ohio

Situated in the State of Ohio, County of Muskingum, Township of Monroe, Quarter Township 3, and being part of Lot 3, Township 3, Range 5, United States Military Lands, and being all of the lands presently owned by Guy R. and Charlene French, as per Deed Record 1071, Page 331, First Parcel, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at a stone found at the northwest corner of Lot 3, Quarter Township 3, Township 3, Range 5, United States Military Lands;

Thence along Lot 3, and Lot 4 lot line, and the south line of lands presently owned by Jonas L. and Fannie J. Schlabach, (OR 2670-822), South 88 degrees 21 minutes 14 seconds East, 1985.09 feet to a point in the centerline of St. Rte 83, passing iron pins set at 17.64 feet, 94.39 feet, and 1481.41 feet, and an iron pin found at 1944.66 feet;

Thence along the centerline of said road the following nine courses:

- 1.) South 40 degrees 02 minutes 27 seconds West, 124.93 feet to a point;
- 2.) South 40 degrees 14 minutes 55 seconds West, 378.55 feet to a point;
- 3.) Along a non-tangent curve to the left having a delta angle of 47 degrees 32 minutes 04 seconds, a radius of 251.82 feet, an arc length of 208.92 feet, from which a chord bears South 20 degrees 45 minutes 58 seconds West, 202.98 feet to a point;
- 4.) Along a non-tangent curve to the left having a delta angle of 38 degrees 18 minutes 15 seconds, a radius of 367.91 feet, an arc length of 245.96 feet, and a chord which bears South 32 degrees 34 minutes 19 seconds East, 241.40 feet to a point;
- 5.) South 42 degrees 40 minutes 55 seconds East, 231.52 feet to a point;
- 6.) South 43 degrees 13 minutes 18 seconds East, 362.72 feet to a point;
- 7.) South 42 degrees 34 minutes 27 seconds East, 131.56 feet to a point;
- 8.) South 40 degrees 38 minutes 30 seconds East, 269.54 feet to a point;
- 9.) Along a non-tangent curve to the right with a delta angle of 14 degrees 23 minutes 59 seconds, a radius of 557.53 feet, an arc length of 140.12 feet, and a chord which bears South 35 degrees 57 minutes 34 seconds East, 139.75 feet to a point on the northeast corner of lands presently owned by Barbara Shields Cavinee, Trustee, (OR 2589-270) and the north line of Lot 2;

Thence along the line between Lot 2, and Lot 3, the following three courses:

- 1.) North 88 degrees 37 minutes 53 seconds West, 1216.61 feet to a stone found, passing an iron pin set at 37.39 feet;
- 2.) North 87 degrees 44 minutes 09 seconds West, 1038.40 feet to an iron pin found;
- 3.) North 88 degrees 17 minutes 07 seconds West, 263.45 feet to a stone found on the southeast corner of lands also presently owned by Guy R. and Charlene French, (DR 1070-331);

Thence along the lot line between Lot 14, and Lot 3, North 01 degrees 42 minutes 31 seconds East, 135.21 feet to a point in the centerline of Guys Road, (Twp. Rd. 340, R\W 40' assumed), passing an iron pin set at 95.57 feet;

Thence along the centerline of said road and being the east lines of lands presently owned by Bonita Joanne Yurich, (OR 1536-119), the following four courses:

- 1.) North 12 degrees 58 minutes 13 seconds East, 30.05 feet to a point;
