LEGAL DESCRIPTION FOR G. GARBAS

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF MONROE AND BEING PART OF LOTS #15 AND #2 OF THE THIRD QUARTER OF TOWNSHIP 3, RANGE 5 OF THE UNITED STATES MILITARY LANDS AND BEING PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 574, PAGE 793 OF THE MUSKINGUM COUNTY DEED RECORDS. FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN SET AT THE NORTHWEST CORNER OF AFORESAID LOT #2 AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, NORTH 89 DEGREES - 49 MINUTES - 22 SECONDS EAST, 265.97 FEET ALONG THE NORTH LINE OF SAID LOT TO AN 1RON PIN SET; THENCE, SOUTH 00 DEGREES - 10 MINUTES - 38 SECONDS EAST, 208.00 FEET TO AN 1RON PIN SET; THENCE, SOUTH 89 DEGREES - 49 MINUTES - 22 SECONDS WEST, 443.69 FEET TO AN 1RON PIN SET; THENCE, NORTH 41 DEGREES - 21 MINUTES - 29 SECONDS WEST, 64.84 FEET TO A SPIKE SET IN TOWNSHIP ROAD #340; THENCE, NORTH 48 DEGREES - 13 MINUTES - 05 SECONDS EAST, 100.42 FEET TO A SPIKE SET; THENCE, NORTH 37 DEGREES - 59 MINUTES - 10 SECONDS EAST, 117.67 FEET TO A SPIKE SET IN SAID ROAD ON THE NORTH LINE OF AFORESAID LOT #15; THENCE, NORTH 89 DEGREES - 49 MINUTES - 22 SECONDS EAST, 72.61 FEET TO THE POINT OF BEGINNING AND CONTAINING 2.00 ACRES MORE OR LESS OF WHICH 1.27 ACRES LIE IN LOT #2 AND 0.73 ACRES LIE IN LOT #15.

ALSO, THERE IS HEREIN RETAINED BY GRANTOR A 20 FOOT EASEMENT FOR PURPOSES OF INGRESS/EGRESS COMMENCING AT THE NORTHWEST CORNER OF ABOVE DESCRIBED PARCEL; THENCE, ALONG SAID TOWNSHIP ROAD, SOUTH 37 DEGREES - 59 MINUTES - 10 SECONDS WEST, 73.10 FEET TO A POINT AND THE TRUE POINT OF DEGINNING FOR THE CENTERLINE OF THIS EASEMENT; THENCE, SOUTH 42 DEGREES - 45 MINUTES - 36 SECONDS EAST, 112.21 FEET TO A POINT; THENCE, SOUTH 45 DEGREES - 31 MINUTES - 14 SECONDS EAST, 76.41 FEET TO A POINT; THENCE, SOUTH 56 DEGREES - 18 MINUTES - 58 SECONDS WEST, 53.79 FEET TO THE TERMINUS OF THIS EASEMENT.
