- TIE-3 THENCE South 87 degrees 57 minutes 03 seconds East 508.26 feet through said McCuley property and along a common line for the above described 126.95 acre parcel and the remainder of said McCulley property to the unmarked place of beginning for the easement herein intended to be described;
- E-1 THENCE North 08 degrees 09 minutes 50 seconds East 538.74 feet through said McCulley remainder to an unmarked point;
- E-2 THENCE South 86 degrees 39 minutes 15 seconds East 81.33 continuing through said McCulley remainder to an unmarked point on a common line for said 126.95 acre parcel and McCulley remainder, further being on the West line of an 30 foot wide easement reserved from the above described 126.95 acre parcel;
