Situated in the State of Ohio, County of Muskingum, Township of Muskingum:

Being a part of the Southwest Quarter of Fractional Section Eight (8), Township Two (2), Range Eight (8) of the United States Military Lands and property now owned by Emil G. and Katherine Eckert and Recorded in Deed Book 1113, Page 8 of the Muskingum County Deed Records bounded and described as follows:

Beginning at a limestone found of the southeast corner of said southwest corner of section 8; thence N 88° 03' 00" W (the base of bearings for this description is State Plane Grid from a Solar Observation) along the south line of said section 8 and the north line of property owned by Amelia Tanner (Vol. 976, pg. 165) a distance of 670.00 feet to an iron pin set; thence N 2° 10' 05" E along the easterly line of Kenneth and Faye Albright (Vol. 546, pg. 810) 660.00 feet to an iron pin set; thence N 88° 03' 00" W along a northerly line of said Albright property 665.47 feet to an iron pin set; thence N 2° 32' 22" E along the easterly line of said Albright property and along property owned by James R. Walton (Vol. 1025, pg. 283) a distance of 906.70 feet to a 3 inch mag nail set in the center of McGlade School Road and passing through a walnut tree at the southeast corner of said Walton property at 504.00 feet and through an iron pin set at 852.40 feet; thence N 40° 13' 36" E along the center of said road and along the southeasterly line of a 0.082 acre parcel owned by James and Margaret Johnson (Vol. 1039, pg. 574) a distance of 117.22 feet to a 3 inch nail set; thence S 88° 03' 34" E along the south line of property owned by Hazel Graves (Vol. 1148, pg. 759) and the south line of property owned by Russell Woodrow (Vol. 582, pg. 243) a distance of 1257.32 feet to an iron pin reset on the east line of said southwest quarter of section 8 passing through an iron pin set at 58.00 feet, a 3/4 inch iron pipe found at 212.77 feet, a 3/4 inch pipe found at 428.43 feet and through an iron pin set at 588.00 feet and through an iron pin set at 1137.03 feet; thence S 2° 10' 05" W along the east line of said section 8 and along the west line of property owned by Rockne and Lois Crockett a distance of 1657.79 feet to the place of beginning and passing through an iron pin set at 482.15 feet and 1162.79 feet containing Forty and six-hundred-six thousandths (40.606) acres.

 - IRON PIN RESET

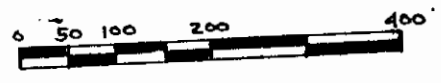

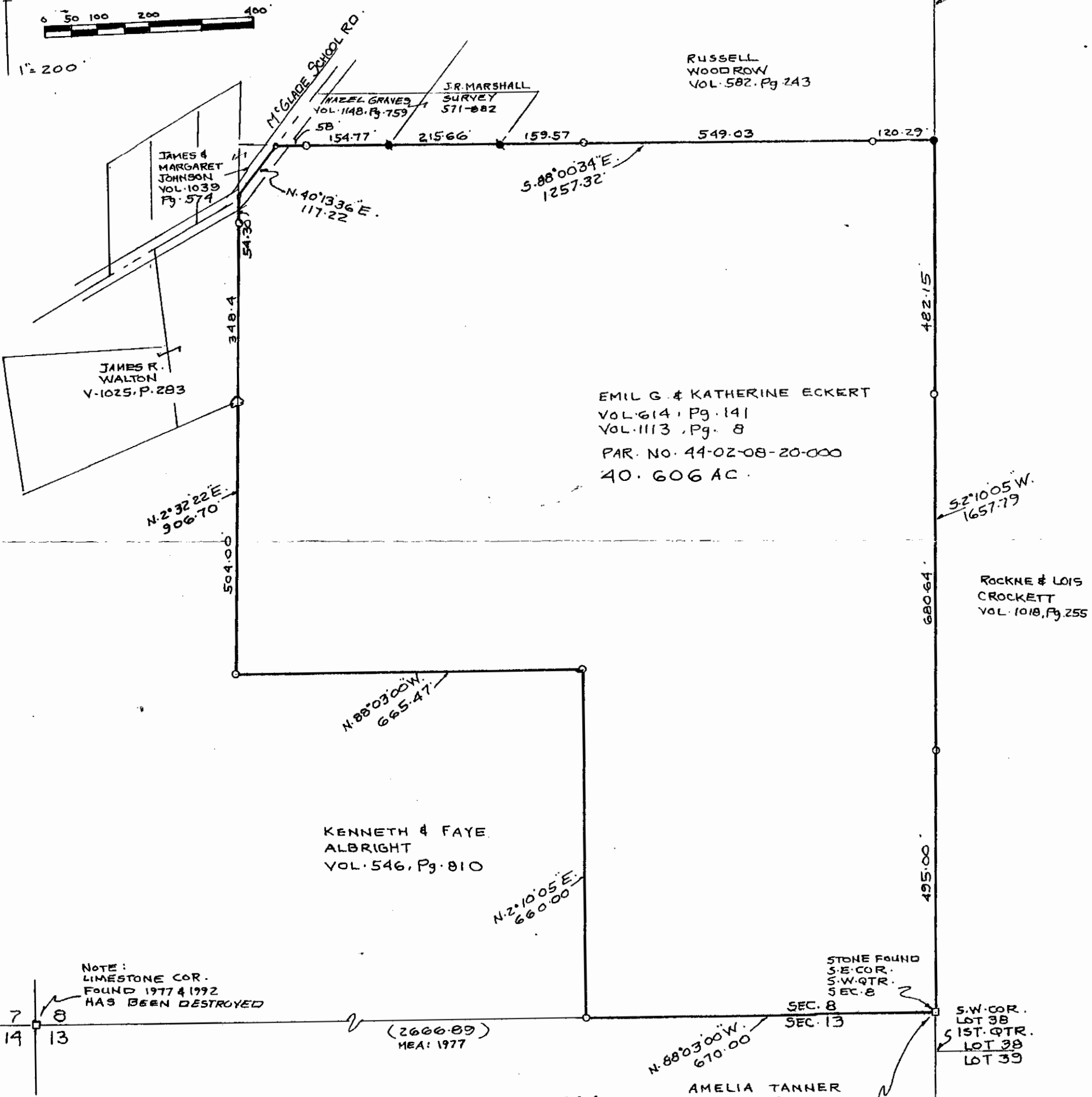
