Thence along the north line of Lot 25, North 88°00′51" West, a distance of 154.67 feet to a capped rebar set:

Thence passing through the parent tract South 13°20′01″ East, a distance of 689.61 feet to a 5/8 inch rebar (3) found on the northeast corner of a parcel of land now or formerly conveyed to Clifford L & Mona D Denney, by a deed recorded in Official Record 3059, Page 429 of the records of the Muskingum County Recorder's Office;

Thence coincident with a easterly line of the parent tract and the west line of said Denney South 18°43′10″ West, a distance of 172.19 feet to a 5/8 inch rebar (4) found on the southwest corner of said Denney, and a corner of the parent tract, and the POINT OF BEGINNING of the parcel herein described, found at coordinates N 759,953.99, E 2,099,720.97;

Thence coincident with the south line of said Denney, and a northerly line of the parent tract South 71°08′40″ East, a distance of 321.24 feet to the centerline of McGlade School Road (County Road 116), passing a 5/8 rebar (5) found at 291.37 feet;

Thence along the centerline of McGlade School Road (County Road 116) the following 2 courses;

- 1. South 09°53'33" East, a distance of 217.39 feet to a point;
- 2. South 09°50′54″ East, a distance of 200.00 feet to the southeast corner of the parent tract, witnessed by a 1/2 inch roof bolt (6) found bent, bearing South 88°05′54″ East, at a distance of 25.54 feet;
