Thence along the north line of Lot 25, North 88°00′51″ West, a distance of 154.67 feet to a capped rebar set on the northeast corner of the parcel herein described, and the POINT OF BEGINNING, coordinates N 760,788.10, E 2,099,617.19;

Thence passing through the parent tract South 13°20′01" East, a distance of 689.61 feet to a 5/8 inch rebar (3) found on the northwest corner of a parcel of land now or formerly conveyed to Clifford L & Mona D Denney, by a deed recorded in Official Record 3059, Page 429 of the records of the Muskingum County Recorder's Office;

Thence coincident with the west line of said Denney and an easterly line of the parent tract, South 18°43′10″ West, a distance of 172.19 feet to a 5/8 rebar (4) found the southwest corner of said Denney;

Thence passing through the parent tract South 20°59′09″ West, a distance of 531.50 feet to a capped rebar set on the southerly line of the parent tract, and the north line of a parcel of land now or formerly conveyed to Brian & Dale F Williams Life Estate Et. Al., by a deed recorded in Official Record 1135, Page 324 of the records of the Muskingum County Recorder's Office;

Thence along the southerly line of the parent tract, and the north line of said Williams, North 88°05′54″ West, a distance of 209.22 feet to a post (8) found of the easterly line of said Williams and the southwest corner of the parent tract;

Thence coincident with the west line of the parent tract North 02°25′29″ East, a distance of 1332.89 feet to the northwest corner of Lot 25, passing a corner stone (9) found on the northeast corner of said Williams at 270.01 feet, also being the southeast corner of a parcel of land now or formerly conveyed to Cheryl A Schneider, by a deed recorded in Official Record 3070, Page 228 (Seventh Parcel) of the records of the Muskingum County Recorder's Office, and passing a 5/8 inch rebar (10) found at 1312.89 feet;

Thence coincident with the north line of Lot 25, also being the south line of a parcel of land now or formerly conveyed to Drake & Bethany A Prouty, by a deed recorded in Official Record 2888, Page 50 of the records of the Muskingum County Recorder's office, and the north line of the parent tract, South 88°00′51″ East, a distance of 239.43 feet, passing a capped rebar set at 86.90 feet, returning to THE POINT OF BEGINNING.
