Situated in the State of Ohio, County of Muskingum, Township of Muskingum, bounded and described as follows:

Being a part of Lot 36 in Quarter Township One, Township 2, Range 8, United States Military Lands, and being part of the lands now owned by Roberta A. Stafford (DR 1529-728), and more particularly described as follows:

Beginning for reference at an iron pin found at the southeast corner of Lot 36 and the southwest corner of lands now owned by F. Schneider (DR 1520-120);
thence along the west line of lands now owned by F. Schneider North 00 degrees 03 minutes 32 seconds East 1503.72 feet to an iron pin set, passing an iron pin found at 1184.60 feet;
thence through lands now owned by Kenneth W. Jr. and Kellye S. Krebs (DR 1099-403) North 78 degrees 17 minutes 37 seconds West 740.71 feet to an iron pin found on the northeast corner of lands now owned by R. Stafford (DR 1529-728);
thence along said Stafford's east line South 25 degrees 57 minutes 51 seconds West 71.20 feet to an iron pin set and the principal place of beginning;
thence continuing along said line South 25 degrees 57 minutes 51 seconds West 78.59 feet to an iron pin found on said Krebs' north line;
thence North 89 degrees 52 minutes 28 seconds West 598.73 feet to an iron pin found on the southeast corner of a 1.00 acre tract owned by Kenneth W. Jr. and Kellye S. Krebs (DR 1099-403);
thence along Krebs' east line of 1.00 acre tract North 00 degrees 08 minutes 20 seconds East 70.73 feet to an iron pin set;
thence through said Stafford's lands South 89 degrees 52 minutes 28 seconds East 632.96 feet to the principal place of beginning, containing 1.00 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Bearings are based on the east line of Lot 36 as bearing South 00 degrees 03 minutes 32 seconds West as recorded Muskingum County Deed Book 1099, Page 403.

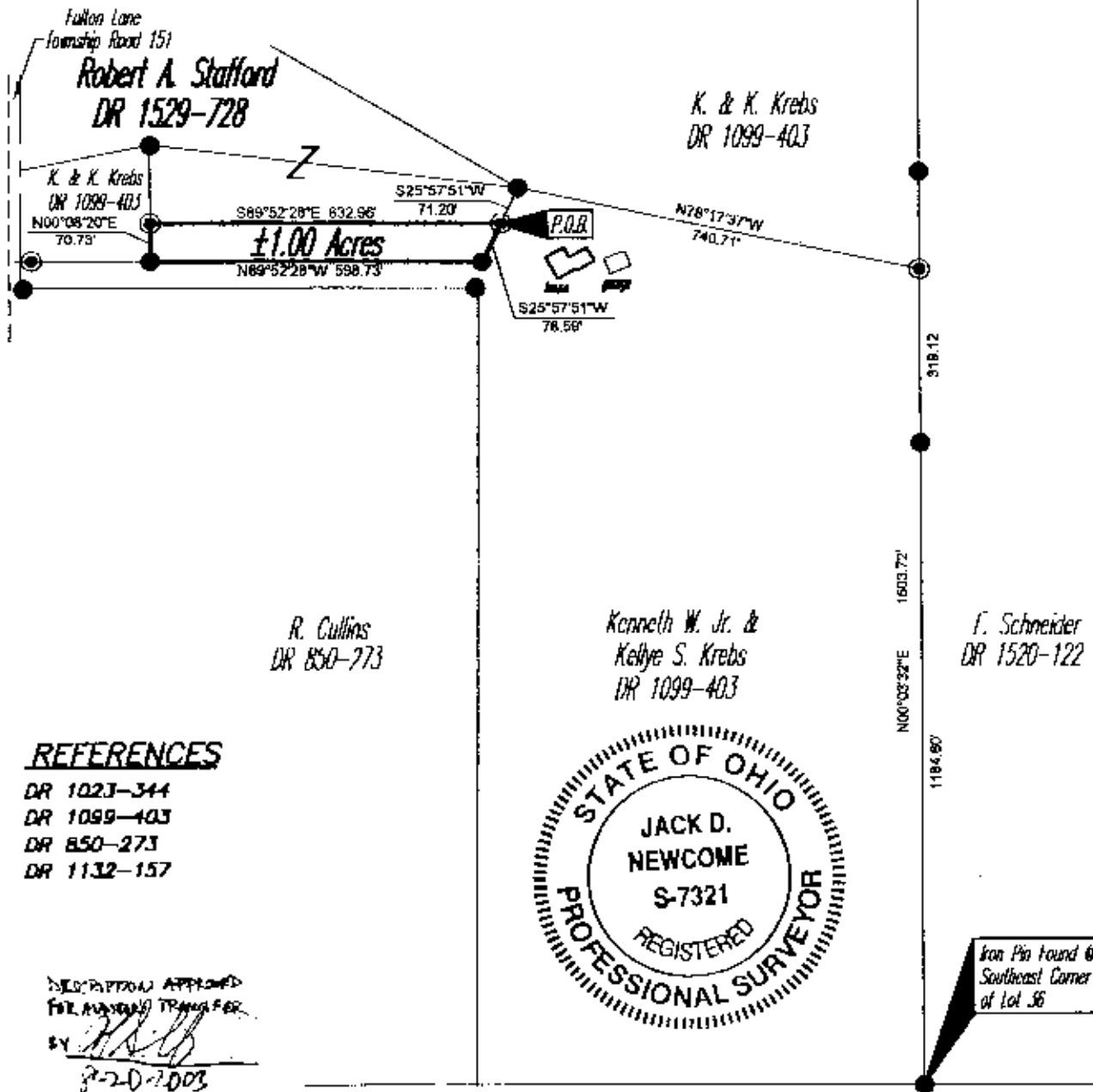

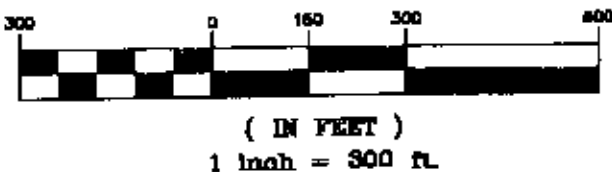
BASIS OF BEARING
