Thence passing through the parent tract North 84°33′59″ West, a distance of 692.50 feet to a 5/8 inch rebar found capped "Biedenbach PS6923 PS7923" on the north corner of a parcel of land now or formerly conveyed to Joshua Schneider, by a deed recorded in Official Record 2919, Page 796 of the records of the Muskingum County Recorder's Office;

Thence coincident with the north line of said Joshua Schneider South 61°23′58″ West, a distance of 383.79 feet to a 5/8 inch rebar found capped "UTI Boundary Monument", passing a 5/8 inch rebar found capped "Biedenbach PS6923 PS7923" at 293.76 feet;

Thence passing through the parent tract the following 3 courses:

- 1. North 40°37′59″ West, a distance of 87.05 feet to a point witnessed by a 5/8 inch rebar found capped "UTI Boundary Monument" bearing (L1) South 78°12′27″ West, a distance of 10.19 feet, and crossing the centerline of New Riley Road (T-441) at 37.58 feet;
- (L2) North 12°00′51″ West, a distance of 275.01 feet to a 5/8 inch rebar found capped "UTI Boundary Monument";
- North 63°04'03" West, a distance of 542.22 feet to a 5/8 inch rebar found capped "UTI Boundary Monument" on the west line of Lot 34, the east line of Lot 37, and the west line of the subject parcel;

Thence coincident with the west line of Lot 34 North 02°00′07" East, a distance of 1415.85 feet to a 5/8 inch rebar found on the northwest corner of the subject parcel, also being the southeast corner of a parcel of land now or formerly conveyed to Adam J & Barbara Larson, by a deed recorded in Official Record 2931, Page 391 of the records of the Muskingum County Recorder's Office;

Thece coincident with the north line of Lot 34, the south line of Lot 35, and the north line of the subject parcel South 88°21′30″ East, a distance of 1632.85 feet to stone found on the corner shared by Lot 34, 35, 26, and 27;

Thence coincident with the east line of Lot 34 and the west line of Lot 27 South 01°48′47″ West, a distance of 1831.62 feet, returning to the POINT OF BEGINNING of the parcel herein described.
