Thence along the east line of Lot 23, and the west line of the said Muskingum County lands South 01 degrees 55 minutes 45 seconds West, 1323.28 feet to a point, on the northwest corner of lands presently owned by the State of Ohio Wild Life, (DR 475-148), from which an iron pin found bears North 88 degrees 04 minutes 15 seconds West, 0.60 feet;

Thence along the west line of said Wild Life lands, South 01 degrees 55 minutes 45 seconds West, 1334.20 feet to the principal place of beginning, containing 93.21 acres, more or less, and being all of Auditor's Parcel Number 44-06-61-01-000 +- 93.21 Acres, (+- 1.33 acres in the R\W of Co. Rd. 116, and +- 0.48 acres in the R\W of Twp. Rd. 151).
