Posey, and Keely P. Bunting, (OR 2560-930);

Thence along the south line of said Lot 28, and the north line of said Posey and Bunting lands, North 88 degrees 02 minutes 13 seconds West, 997.19 feet to an iron pin found on the southeast corner of lands presently owned by Thomas and Nathan Posey, (OR 2614-46);

Thence along the east lines of said Posey lands the following two courses:

- 1.) North 01 degrees 57 minutes 36 seconds East, 99.15 feet to an iron bar found;
- 2.) North 08 degrees 02 minutes 51 seconds West, 37.00 feet to a point in the centerline of McGlade School Road, (Co. Rd. 116, R\W 40'), passing an iron pin found at 27.00 feet;

Thence along the centerline of said road the following six courses:

- 1.) North 54 degrees 35 minutes 06 seconds East, 58.70 feet to a point;
- 2.) North 50 degrees 21 minutes 26 seconds East, 50.67 feet to a point;
- 3.) North 42 degrees 50 minutes 17 seconds East, 100.89 feet to a point;
- 4.) North 35 degrees 46 minutes 38 seconds East, 246.01 feet to a point;
- 5.) North 40 degrees 24 minutes 06 seconds East, 105.64 feet to a point;
