

0.01 Acre Adjoiner Split

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, and being part of Lot 31, in Quarter Township 1, Township 2, Range 8, of the United States Military Lands, and being part of Lot 36, of Eaglepoint Subdivision Phase 2, as found in Plat Book 18, Page 158, and 159, of the Muskingum County Records, and being more particularly described as follows:

Beginning for reference at an iron pin found at the Southeast corner of Lot 38, of Eaglepoint Subdivision Phase 2, (Pl. Bk. 18, Pg. 158 and 159), and the principal place of beginning;

Thence along the west line of the right of way of Cassies Way, on a curve to the left, with a radius of 350.00 feet, an arc length of 28.59 feet and a chord which bears South 32 degrees 40 minutes 47 seconds West, 28.58 feet to an iron pin set;

Thence leaving said right of way and through the lands presently owned by Diane E. and Richard W. Trout Jr.,(OR 2278-744), North 57 degrees 50 minutes 43 seconds West, 45.88 feet to a point on the lot line between Lot 36 and 38;

Thence along said lot line, South 89 degrees 37 minutes 02 seconds East, 54.28 feet to the principal place of beginning, containing 0.01 acres more or less;

Subject to all legal recorded easements and right of ways.

Bearings are based on the south line of Lot 38, as per the plat of Eaglepoint Subdivision Phase 2, and being North 89 degrees 37 minutes 02 seconds West.


