**SURVEY DESCRIPTION
FOR
Stephen M. Bowman**

**PART OF PARCEL
44-06-51-12-000 (10.092 Acres)**

Situated in lot 37, Quarter Township 1, T-2-N, R-8-W, U.S.M.L., Muskingum Township, Muskingum County, Ohio. Being part of the lands of Stephen M. Bowman as conveyed in Deed Book 1138 Page 329 of the Muskingum County Deed Records, and being described as follows:

Beginning at an iron pin found in the Northeast corner of lot 37;
thence, **S.00°27'20"W.** a distance of **461.12** feet along the east line of Lot 37 to a set rebar;
thence, **N.89°55'10"W.** a distance of **828.91** feet through the lands of S. Bowman (1138/329) to a set rebar on the easterly side of a 60 foot right of way;
thence, **N.26°21'18"W.** a distance of **188.19** feet along said right of way and through said Bowman lands to a set rebar;
thence, on a curve to the left a distance of **118.29** feet, on a radius of **50.00** feet, whose chord bears **N.40°59'57"W.** a distance of **92.57** feet along said right of way and through said Bowman lands to a set rebar;
thence, **N.15°33'39"W.** a distance of **240.58** feet through said Bowman lands to a set rebar on the North line of lot 37;
thence, **S.89°25'59"E.** a distance of **1,041.43** feet along said lot line to the point of beginning.

The above described parcel contains 10.092 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

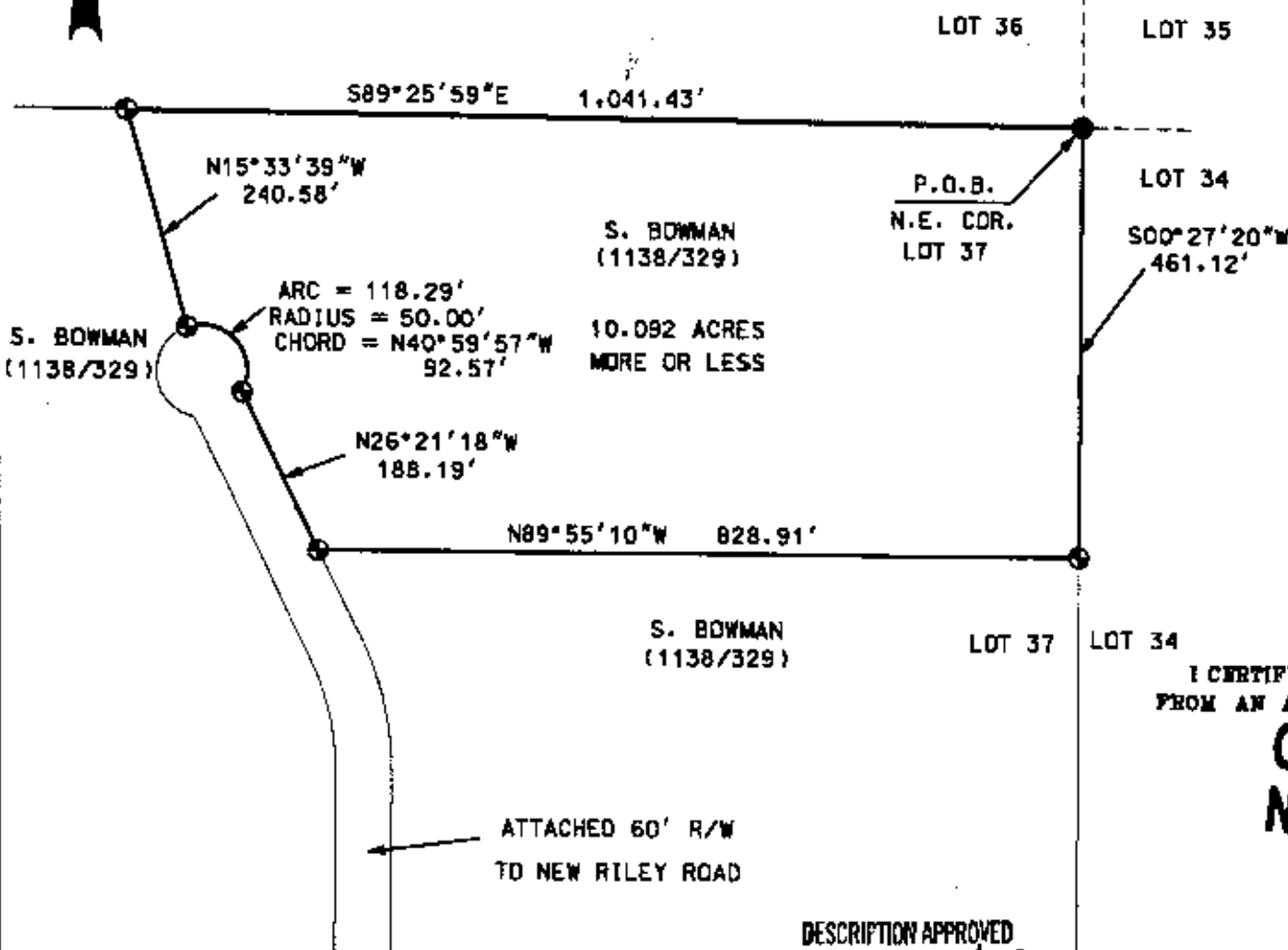
