PART OF AUDITORS PARCEL

Situated in lot 31, Quarter Township 1, T-2-N, R-8-W, U.S.M.L., Muskingum Township, Muskingum County, Ohio. Being part of lot 17 in Eaglepoint Subdivision, Phase 1, recorded in Plat Book 18 page 113 of the Muskingum County Plat Records and being described as follows:

Beginning at the Southwest corner of lot 16 of Eaglepoint Subdivision, Phase 1;

Thence, **S.71°12'43"E.** a distance of **403.58** feet along the South line of lot 16 to a found iron pin on the West line of Eaglepoint Drive;


Thence, **N.80°55'38"W.** a distance of **208.79** feet through lot 17 to a set rebar;

Thence, **N.61°06'41"W.** a distance of **200.90** feet through lot 17 to the point of beginning.

The above described parcel contains 0.16 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

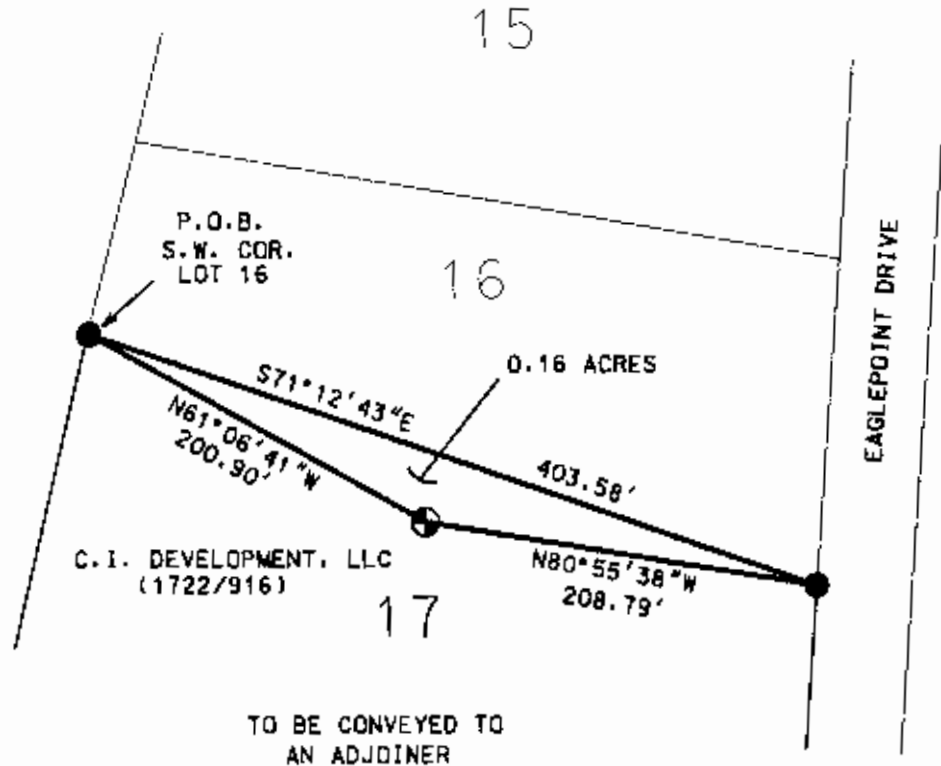
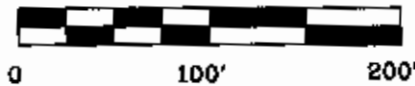
