**SURVEY DESCRIPTION
FOR
MARK BLATT**

PART OF AUDITORS PARCEL
44-12-03-35-003 (2.01 Acres)

Situated in lot 24, Quarter Township 3, T-2-N, R-8-W, U.S.M.L., Muskingum Township, Muskingum County, Ohio. Being part of the lands of Mark Blatt conveyed in Deed Book 1840 page 418 of the Muskingum County Deed Records and being described as follows:

Commencing at the Northeast corner of Lot 24; Thence, S.06°04'33"W. a distance of 1420.43 feet along the East line of said lot to a point, located in McCaslin Road (T.R. 148), **BEING THE POINT OF BEGINNING;**

Thence, S.06°04'33"W. a distance of 278.34 feet along said lot line and along said road to a point;

Thence, N.62°20'00"W. a distance of 390.03 feet leaving said lot line and said road, through the lands of Mark Blatt (1840/418) to a set rebar, passing a set rebar at 25.21 feet;

Thence, N.26°18'33"E. a distance of 253.51 feet through said Blatt lands to a set rebar;

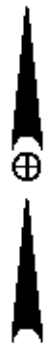
Thence, S.63°22'49"E. a distance of 293.66 feet through said Blatt lands to the point of beginning, passing a set rebar at 259.06'.

The above described parcel contains 2.01 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

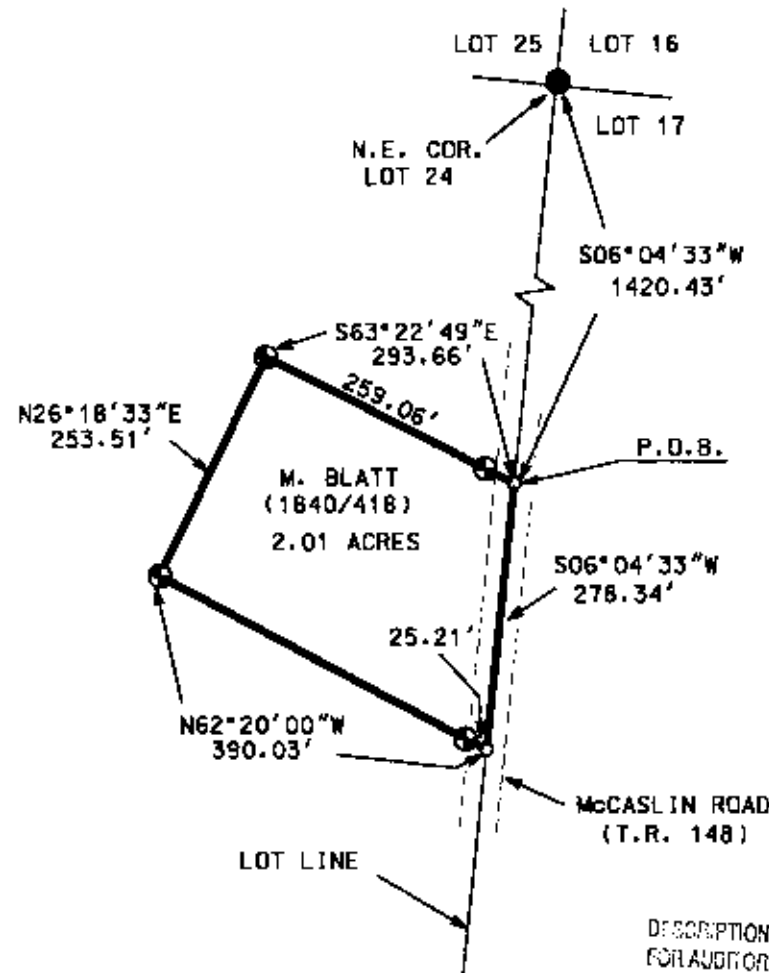


SURVEY PLAT FOR DAVID McCARTY
