PART OF AUDITORS PARCEL  
44-14-01-01-000 (1.11 Acres) *SNR*

Situated in Lot 5, Quarter Township 3, T-2-N, R-8-W. Muskingum Township, Muskingum County, Ohio.

Beginning at a found iron pin on the South line of Lot 5, marking the Northwest corner of lot 7 of Wilson Lane Subdivision #2 (P.B. 18, Pg. 103);

Thence, **S.86°47'24"W.** a distance of **189.25** feet along the South line of Lot 5 to a set rebar;

Thence, **N.03°12'37"W.** a distance of **199.20** feet through the lands of Crimson King Farms (1855/634) to a set rebar;

Thence, **N.86°47'24"E.** a distance of **244.91** feet through said Farm lands to set rebar;

Thence, **S.02°09'32"E.** a distance of **199.23** feet through said Farm lands to set rebar on the South line of lot 5;

Thence, **S.86°47'24"W.** a distance of **52.01** feet along said Lot line to the point of beginning.

The above described parcel contains 1.11 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

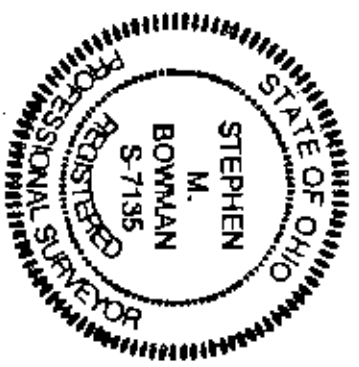
SURVEY PLAT FOR CRIMSON KING FARMS
