**SURVEY DESCRIPTION

PART OF AUDITORS PARCEL
44-14-01-04-000 (2.749 Acres)

Situated in Lot 6, Quarter Township 3, T-2-N, R-8-W, Muskingum Township, Muskingum County, Ohio. Being part of the lands of Jon and Sharon McCarty last conveyed in Deed Book 1685 Page 206 of the Muskingum County Deed records and being described as follows:

Commencing at the Southwest corner of Lot 6; Thence, N.03°13'05"W. a distance of 605.74 feet along the West line of lot 6 to a point; Thence, N.86°46'55"E. a distance of 256.78 feet through lot 6 to a point in the center of Gorsuch Road, **BEING THE POINT OF BEGINNING**;

Thence, N.06°29'49"E. a distance of 840.63 feet through the lands of J. & S. McCarty (1685/206) to a set rebar, passing a set rebar at 19.80 feet;

Thence, N.71°40'55"E. a distance of 383.37 feet through said McCarty lands to a set rebar;

Thence, S.11°54'30"E. a distance of 232.52 feet through said McCarty lands to a set rebar;

Thence, S.82°57'22"W. a distance of 360.67 feet through said McCarty lands to a set rebar;

Thence, S.08°19'23"W. a distance of 720.37 feet through said McCarty lands to a point in the center of Gorsuch Road, passing a set rebar at 689.58 feet;

Thence, N.57°16'36"W. a distance of 53.28 feet along the center of said road to the point of beginning.

The above described parcel contains 2.749 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

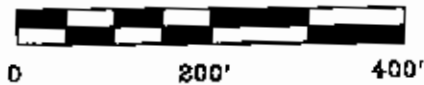
