Survey Split of Michael S. and Lisa K. Havens Lands in Muskingum, Twp., Muskingum Co.

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, Quarter Township 3, Military Lot 7, and being part of Lot 5, of Plow Share Acres Subdivision, (Pl. Bk. 12, Pg. 62, and 63), Township 2, Range 8, United States Military Lands, and being part of the lands presently owned by Michael S. and Lisa K. Havens, as per Deed Record 1147, Page 461, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at the Northwest corner of Lot 5, of Plow Share Acres Subdivision, (Pl. Bk. 12, Pg. 62, and 63), and being a point in Welsh Road, (Twp. Rd. 471);

Thence along the north line of said Lot 5, South 87 degrees 59 minutes 43 seconds East, 375.07 feet to a point in the centerline of a stream, passing a pipe found at 25.00 feet and an iron pin set at 361.35 feet;

Thence through said Lot 5, and along the centerline of said stream, the following three courses:

- 1.) South 14 degrees 11 minutes 32 seconds West, 175.78 feet to a point;
- 2.) South 14 degrees 21 minutes 19 seconds East, 38.48 feet to a point;
- 3.) South 01 degrees 12 minutes 27 seconds East, 51.07 feet to a point on the north line of Lot 6, of said Plow Share Acres;

Thence along the north line of said Lot 6, North 87 degrees 59 minutes 41 seconds West, 353.45 feet to a point in Welsh Road, (Twp. Rd. 471), and being on the southwest corner of said Lot 5;

Thence along the west line of said Lot 5, North 02 degrees 23 minutes 58 seconds East, 259.74 feet to the principal place of beginning, containing 2.11 acres, more or less, and being part of Auditor's Parcel Number 44-14-02-14-000.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars, 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North as per GPS observations.
