Being a parcel of land located in Lot No. 14 of the United States Military Lands, Quarter Township 3, Town 2 North, Range 8 West, Muskingum Township, Muskingum County, Ohio and bounded and described as follows:

Commencing at the Southeast corner of said Lot No. 14 and being in Township Road No. 471; thence North 00 degrees 03 minutes 00 seconds West 1079.52 feet along the East line of said Lot No. 14 to the point of beginning; thence from this true point of beginning South 86 degrees 16 minutes 51 seconds West 281.87 feet (passing through an iron pin set at 33.20 feet) to an iron pin set; thence North 00 degrees 13 minutes 53 seconds West 101.54 feet to an iron pin set; thence North 78 degrees 17 minutes 03 seconds East 287.55 feet (passing through an iron pin set at 253.28 feet) to the East line of said Lot No. 14 and being in Township Road No. 471; thence South 00 degrees 03 minutes 00 seconds East 141.65 feet along the East line of said Lot No. 14 to the point of beginning and containing 0.786 acres, more or less.

Surveyed in September, 1994 by John G. Eppley Registered Surveyor No. 6410. Iron pins are one half inch rebar 30 inches long with identification caps.

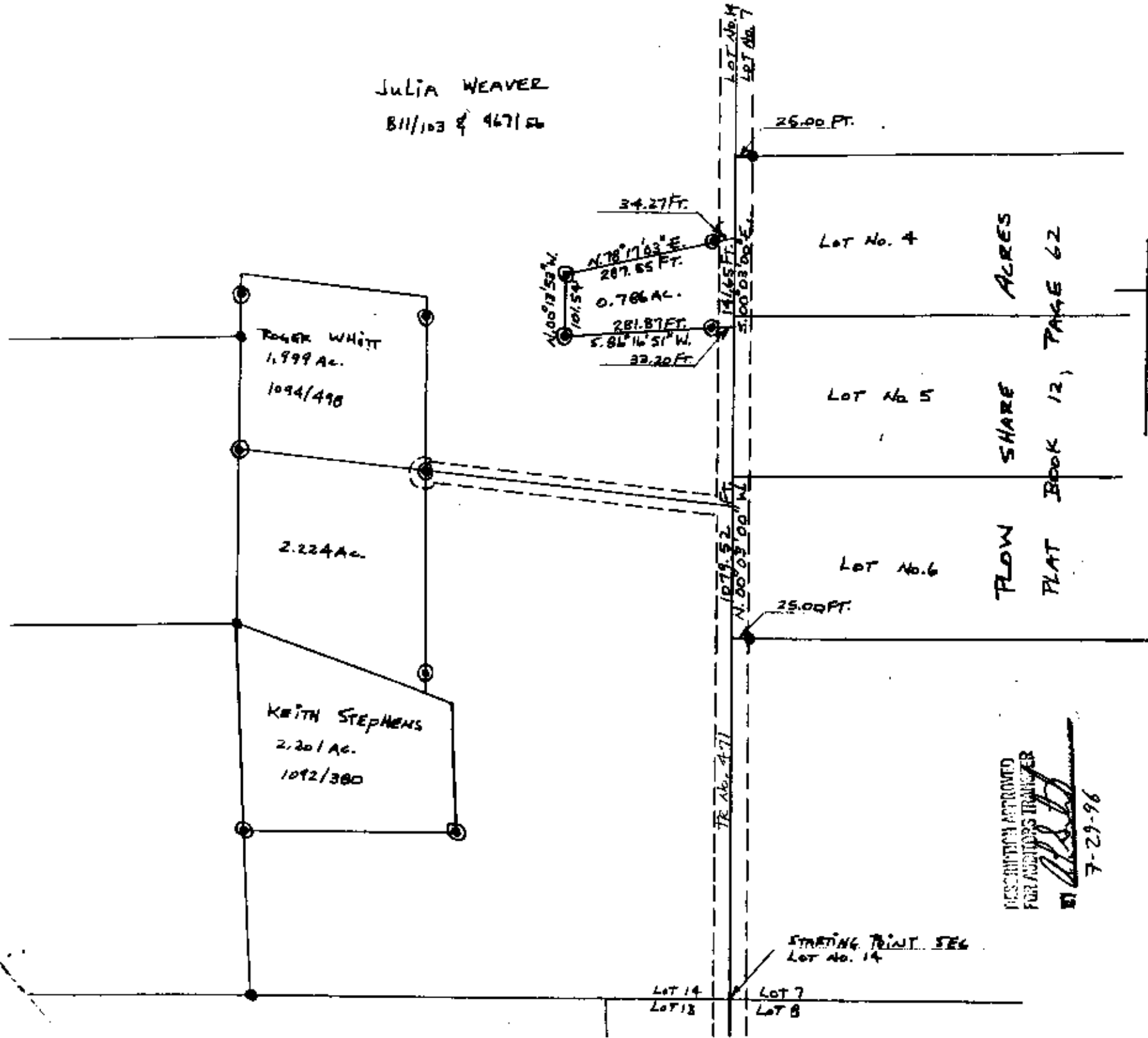

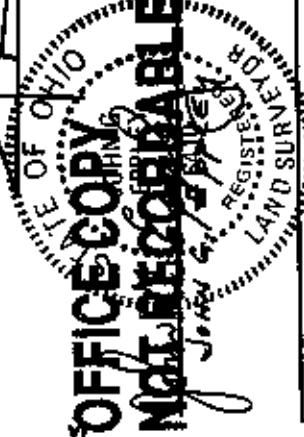
