DESCRIPTION OF A 1.251 ACRE TRACT

Situate in the State of Ohio, County of Muskingum, Township of Muskingum, and being part of Lot # 14, in the Third Quarter Township, Township 2 North, Range 8 West in the United States Military District and being part of the Rocky J. Brownfield property recorded in Volume # 1734, Page 409, and part of Parcel # 44-14-02-22-014, of Muskingum County records and being more particularly described as follows ;

Beginning for Reference at the Northeast corner of Lot # 14, in the Third Quarter Township, Township 2 North, Range 8 West, thence along the east line of Lot # 14, South 00 degrees 03 minutes 00 seconds East 921.31 feet to a point in Welsh Road (Twp. Rd. # 471) ; thence continuing along the east line of Lot # 14 and said road South 00 degrees 03 minutes 00 seconds East 30.00 feet to a point and the True Place of Beginning ; thence continuing along said line, Welsh Road, and Robert and Edith Sellers property (Vol. 1082, Pg. 126) , South 00 degrees 03 minutes 00 seconds East 141.55 feet to a point in Welsh Road ; thence along a new line crossing Rocky J. Brownfield property South 89 degrees 15 minutes 46 seconds West 385.00 feet to an iron pin set , passing an iron pin set at 30.00 feet ; thence along a new line crossing said Brownfield property North 00 degrees 03 minutes 00 seconds West 141.55 feet to an iron pin set ; thence North 89 degrees 15 minutes 46 seconds East 385.00 feet to a point in Welsh Road (Twp. Rd. # 471) at the True Place of Beginning , passing an iron pin set at 355.00 feet.

Containing 1.251 acres , more or less, subject to all easements , restrictions , or right of ways , either written or implied. All iron pins set and found are # 5 rebar 30 inches long with a yellow I.D. cap labeled "BINCKLEY S - 7879" .

Bearings on this description are assumed on the east line of Lot # 14, in the Third Quarter Township, Township 2 North, Range 8 West in the United States Military District as being South 00 degrees 03 minutes 00 seconds East as previously surveyed by J.G.Eppley and are for angular calculation only.


