Thence, N.76°11'52"E. a distance of 462.52 feet along said Gas lands to a found iron pin;

Thence, N.65°24'01"E. a distance of 502.70 feet along the South line of The lands of M. Lane to a found iron pin;

Thence, N.88°03'20"E. a distance of 668.31 feet along said Lane lands to A found axle on the East line of Lot 4;

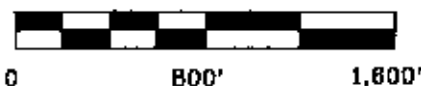

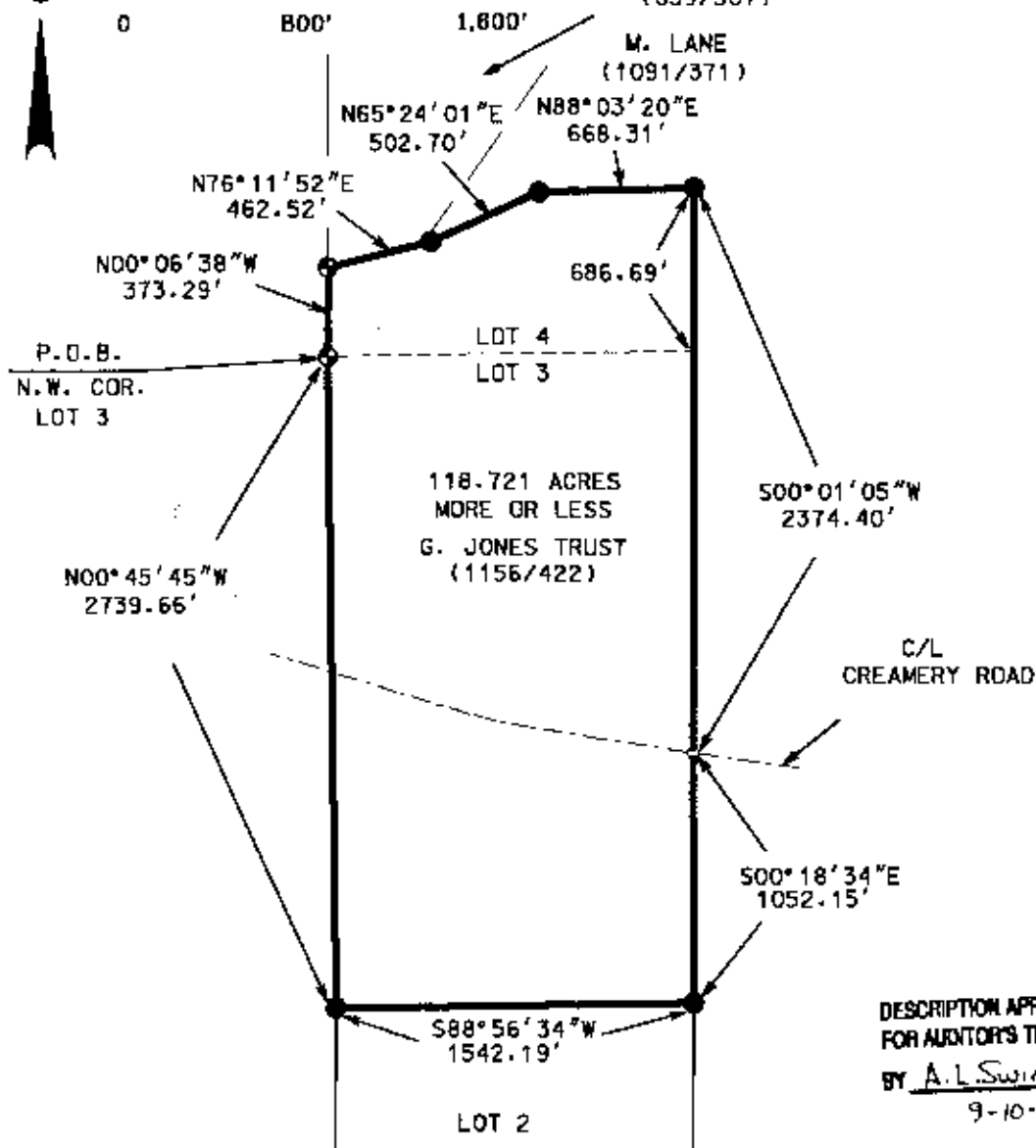

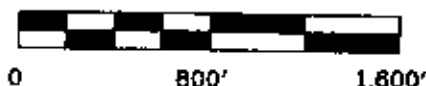
