Situated in the State of Ohio, County of Muskingum, Township of Muskingum.

Being a part of Lot 13 in Quarter Township 3, Township 2, Range 8 bounded and described as follows:

Commencing at the Northwest Corner of said Lot 13; thence south 0 degrees 26 minutes 16 seconds east 56.50 feet to a point; thence north 89 degrees 43 minutes 02 seconds east 220 feet to an iron pin; thence north 0 degrees 16 minutes 58 seconds west 54.96 feet to an iron pin; thence along the north line of said Lot 13 south 89 degrees 55 minutes 33 seconds east 632.98 feet to an iron pin; thence south 10 degrees 48 minutes 52 seconds west 356.23 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence south 10 degrees 48 minutes 52 seconds west 283.69 feet to a point in the center of Creamery Road; thence along said centerline north 89 degrees 23 minutes 58 seconds west 141.81 feet to a point; thence continuing along said centerline north 88 degrees 58 minutes 42 seconds west 186.51 feet to a point; thence leaving said roadway north 0 degrees 26 minutes 16 seconds west 274.35 feet along the east line of Shala Circle; thence south 89 degrees 55 minutes 33 seconds east 383.61 feet to the true place of beginning, containing two and twenty-six hundredths (2.26) acres more or less.
