Thence S 12° 27' 44" W, a distance of 2082.67 feet continuing along said right of way line to an iron pin set;

Thence southwesterly 1069.41 feet along the arc of a curve deflecting to the right having a radius of 11559.16 feet and a chord which bears S 09°48' 42" W, a distance of 1069.03 feet continuing along said right of way line to an iron pin set;

Thence N 87° 36' 13" W, a distance of 70.73 feet along the grantor's southerly property line and the northerly line of said Obenour tract to **THE TRUE POINT OF BEGINNING** and containing 20.950 acres, more or less. Subject to all legal highways, easements and restrictions of record.


