Being a part of the Southeast quarter of Section 19, Township 2, North: Range 8, West, United States Military Lands, Muskingum Township, Muskingum County, State of Ohio and being a part of the tract last transferred to Adam E. and Elizabeth P. Hubbard as recorded in deed book 1127 page 920 of the said county records and being further described as follows.

Beginning for reference at an iron pin found at the Northeast corner of said Southeast quarter. Thence along the North line of the Southeast quarter North 87 degrees 13 minutes 27 seconds West 491.75 feet to a Mag Nail set in Vista View Road and on the North line of said Quarter said point being the place of beginning for the tract herein described. Thence leaving said North line South 04 degrees 13 minutes 29 seconds East 317.99 feet to a 3/4" iron pipe found. Thence South 85 degrees 38 minutes 21 seconds West 120.94 feet to an iron pin found. Thence North 03 degrees 04 minutes 16 seconds West 332.37 feet to a Mag Nail set on the North line of the Southeast quarter of section 19, passing an iron pin found at 297.70 feet. Thence along the North line of said Southeast quarter South 87 degrees 13 minutes 27 seconds East 115.11 feet to the place of beginning. containing 0.8783 acre acres more or less. Subject to all easements and right of ways either written or implied.

Also an ingress egress easement for access to the above described tract and being described as follows.

Beginning at a Mag Nail set at the Northeast corner of the above described 0.8783 acre tract. Thence along the North line of said tract North 87 degrees 13 minutes 27 seconds West 8.77 feet to a Mag Nail set. Thence Leaving said North line South 05 degrees 47 minutes 15 seconds East 319.17 feet a 3/4" iron pipe found. Thence along the West line of said tract North 04 degrees 13 minutes 29 seconds West 317.99 feet to the place of beginning.

All iron pins set are 5/8" by 30" rebar with I.D. caps stamped "Walton S-7675".

Bearings based on a previous survey by Richard Max Graves, dated 7-18-97 and are for angular calculation only.
