

**PARCEL 3WL  
NORTHPOINTE DRIVE**

**IN THE NAME AND FOR THE USE OF THE MUSKINGUM COUNTY  
TRANSPORTATION IMPROVEMENT DISTRICT**

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, and being a part of Section 20, Township 2, Range 8 of the United States Military Lands and being more particularly described as follows:

**Beginning** at a stone found at the grantor's southwesterly property corner on the westerly line of said Section 20, said point being N 01° 51' 35" E, a distance of 1358.22 feet from a stone found with an 'X' cut at the southwest corner of Section 20 and being **THE TRUE POINT OF BEGINNING**;

Thence N 01° 51' 35" E, a distance of 1313.66 feet along the grantor's westerly property line and the westerly line of said Section 20, said line also being the easterly line of a tract of land conveyed to Vista View Village, Inc. by Deed Book 643, Page 10, L.S. Bailey by Deed Book 1141, Page 9 and Ohio Power Company by Deed Book 670, Page 135 to an iron pin set at the grantor's northwesterly property corner;

Thence S 87° 28' 46" E, a distance of 254.06 feet along the grantor's northerly property line and the southerly line of a tract of land conveyed to Scott W. Obenour by Deed Book 974, Page 10 to an iron pipe found at the northwesterly corner of a tract of land conveyed to Jack Newcome by Deed Book 1141, Page 87;

Thence S 04° 03' 24" E, a distance of 383.19 feet along the grantor's easterly property line and the westerly line of said Newcome tract to an iron pin found at the southwesterly corner of the Newcome tract;

Thence S 06° 42' 22" W, a distance of 680.25 feet across the grantor's property to an iron pin set;

Thence S 12° 40' 20" E, a distance of 263.05 feet continuing across the grantor's property to an iron pin set;

Thence N 87° 35' 38" W, a distance of 302.09 feet along the grantor's southerly property line and the northerly line of a tract of land conveyed to Brian G. Jasper & Rae Ann Jasper by Deed Book 1147, Page 677 to **THE TRUE POINT OF BEGINNING** and containing 8.088 acres, more or less. Subject to all legal highways, easements and restrictions of record.

The above described area is contained within the Muskingum County Auditor's Parcel Number 44-40-02-03-000 of which 0.017 acres, more or less are in the present road occupied.

Grantor claims title by instrument(s) recorded in Deed Book 1029, Page 278 of the Muskingum County Recorder's Office.

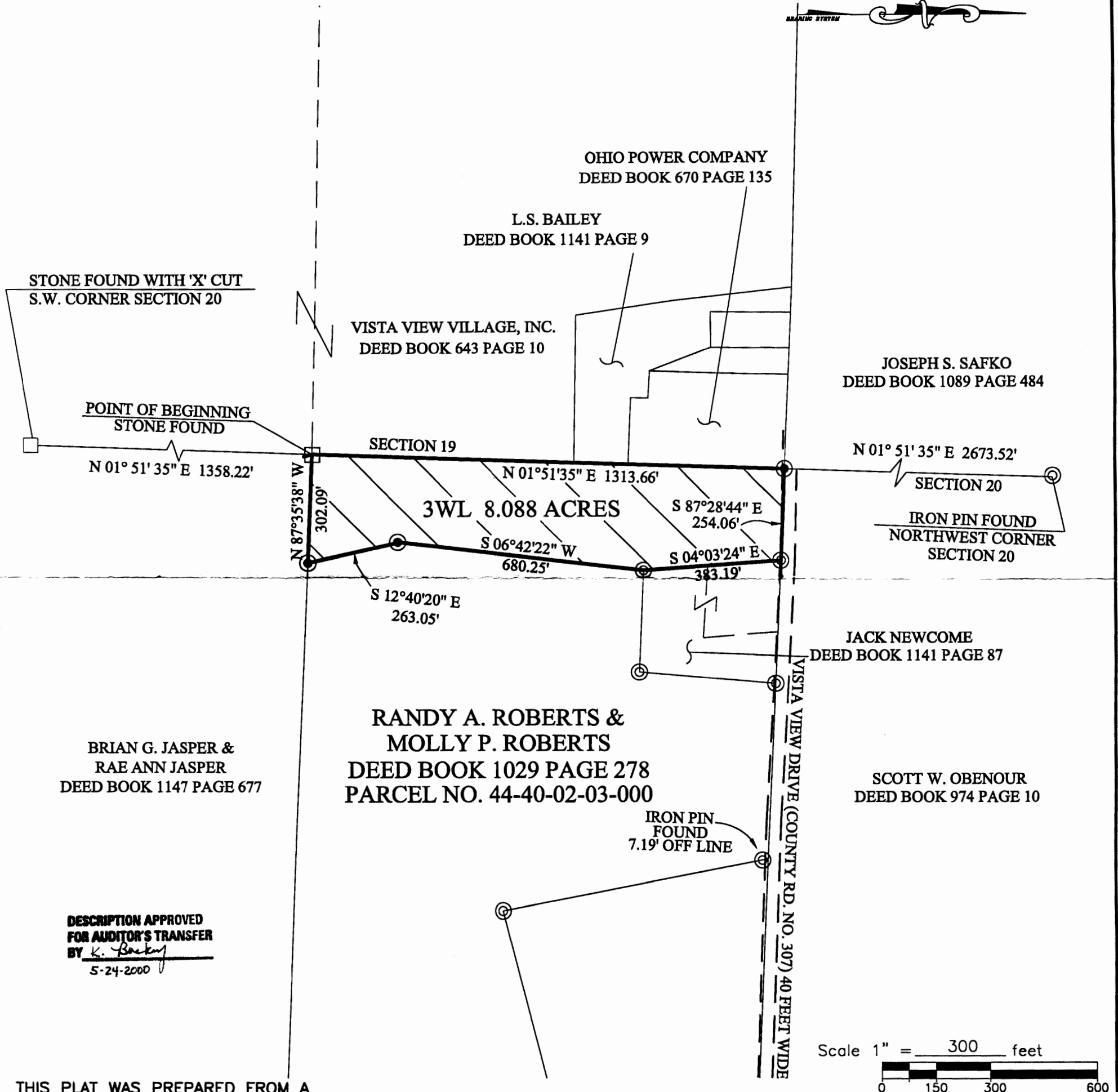

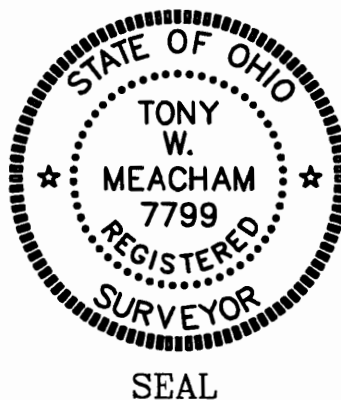
