Being a part of the Southwest Quarter and the Southeast Quarter of Section Twenty (20), Township Two (2), Range Eight (8) of the United States Military Lands and part of property now owned by Charles Eugene and Mary Lou Scott and Recorded in Deed Book 1079, Page 548 of the Muskingum County Deed Records bounded and described as follows:

Commencing at an iron pin found at the southeast corner of said southwest quarter of section 20; thence N 2° 14' 49" E (the base of bearings for this description is true north by an observation of the sun) along the Half Section line 657.55 feet to an axle found at the southwest corner of Parcel One, said Scott property and the true place of beginning for the following described parcel; thence N 2° 06' 54" E along the Half Section line 51.00 feet to a point in Dresden Road; said point bears N 63° 07' 49" W 41.01 feet from an iron pin set; thence N 33° 21' 59" W along the center of said Dresden Road 167.71 to a point, and passing from Parcel One into Parcel Two at 152.71 feet; thence N 82° 21' 23" E 235.25 feet to an iron pin set and passing through an iron pin set at 24.06 feet and through a point on the Half section line and from Parcel Two into Parcel One at 98.78 feet; thence S 5° 36' 23" E 170.05 feet to a point in Frame Road on the south line of Parcel One and passing through an iron pin set at 146.61 feet; thence S 71° 34' 57" W along the south line of said Parcel One and along said Frame Road 168.02 feet to the true place of beginning containing Eight-hundred-seven-thousandths (0.807) of an acre.

Part of Auditors Parcel No. 44-40-03-05-000 (0.045 Ac.) in the southwest quarter of section 20.

Part of Auditors Parcel No. 44-42-01-08-000 (0.635 Ac.) in the southeast quarter of section 20.

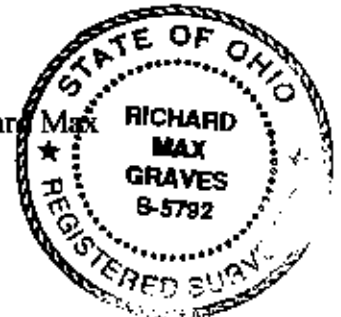

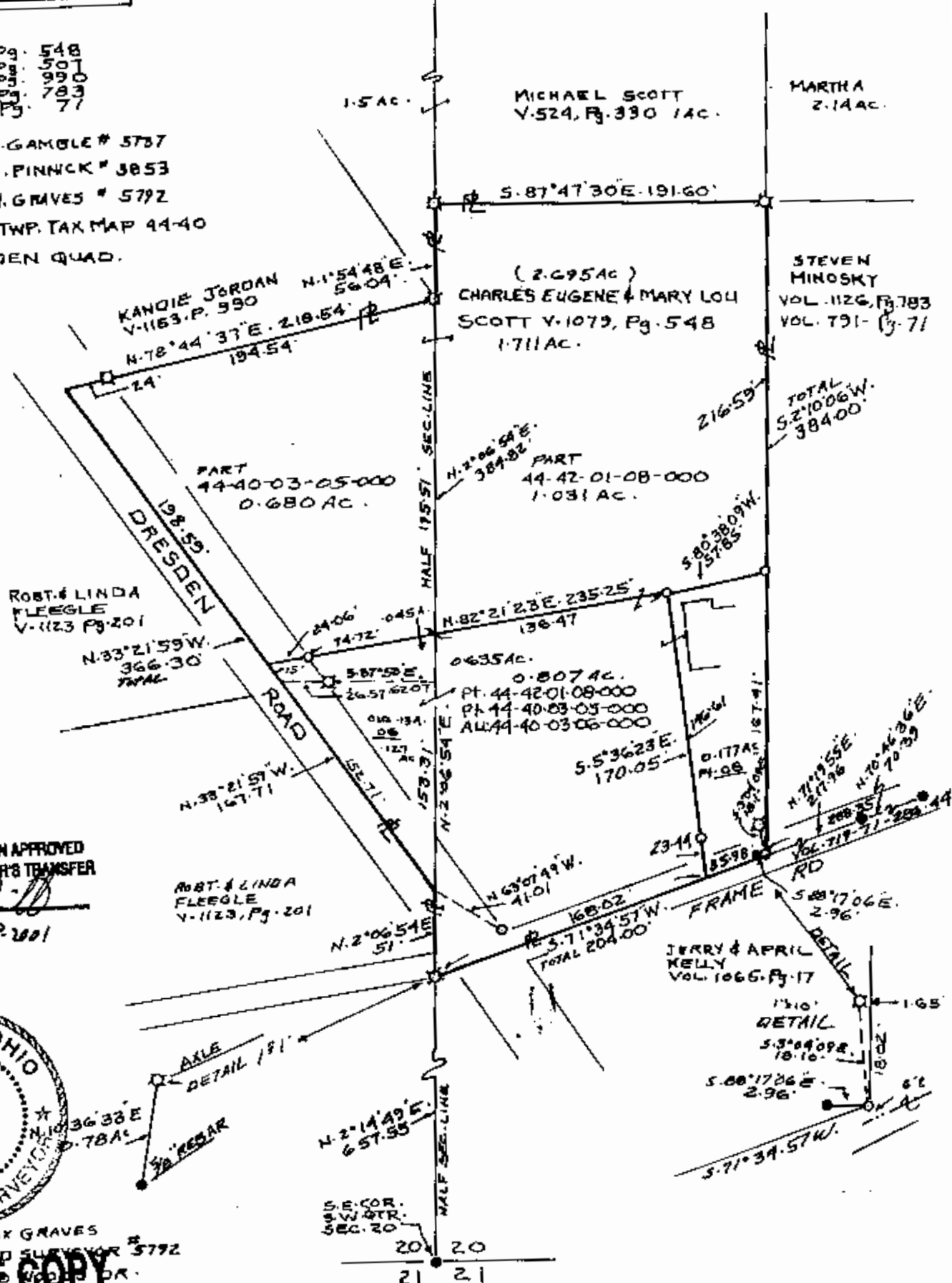
