Scott and Margaret E. Scott to Michael G. Scott by deed recorded in Vol. 524, page 330 of the Muskingum County Deed Records; thence South 83 degrees 07 minutes East, along the southerly line of said Scott tract, 191.0 feet to an iron pin (axle) found at the Southeast corner thereof and being the True Place of Beginning of the premises herein intended to be described; thence continuing South 83 degrees 07 minutes East, and severing the land of the grantors herein, 265.61 feet to an iron pipe set on the east line thereof; thence North 06 degrees 26 minutes East along the said east line 383.23 feet to the Northeast corner of the lands of the grantors herein; thence South 83 degrees 44 minutes West 269.67 feet to the northwest corner of the lands of the grantors herein; thence South 06 degrees 53 minutes West 321.87 feet to the True Place of Beginning, passing through an iron pin (axle) found at the Northeast corner of said Scott one (1) acre tract at 56.67 feet.
