Kosick (Vol.1091, Pg.268) a distance of 1844.08 feet to a railroad spike set in the center of Conn Road and passing through an iron pin set at 1825.59 feet; thence along the center of Conn Road and the west line of property owned by Vernon and Dorothy Prouty (Vol.730, Pg.243) S 30 27 42 W 46.28 feet to a railroad spike set; thence along the center of said road, the west line of said Prouty property and the west line of Idlewild No. 2 (Plat Book 14, Pg.97) on a curve to the right having a radius 524.87 feet (the chord of which bears S 40 58 21 W 200.51 feet) an arc distance of 201.75 feet to a railroad spike set at the northwest corner of said Idlewild No. 2; thence along the center of said road and the west line of a 1.44 acre parcel owned by Alice Swingle (Vol.296, Pg.275) S 47 42 49 W 135.59 feet to a railroad spike set; thence along said centerline and the west line of said 1.44 acre parcel on a curve to the left having a radius of 338.27 feet (the chord of which bears S 44 48 38 W 34.27 feet) an arc distance of 34.28 feet to a railroad spike set; thence N 64 52 50 W 249.27 feet to an iron pin set and passing through an iron pin set at 32.18 feet; thence N 80 40 52 W 178.72 feet to an iron pin set; thence S 8 49 08 W 55.32 feet to an iron pin set; thence N 87 45 40 W 1184.24 feet to the true place of beginning containing ten and twenty hundredths (10.20) acres.

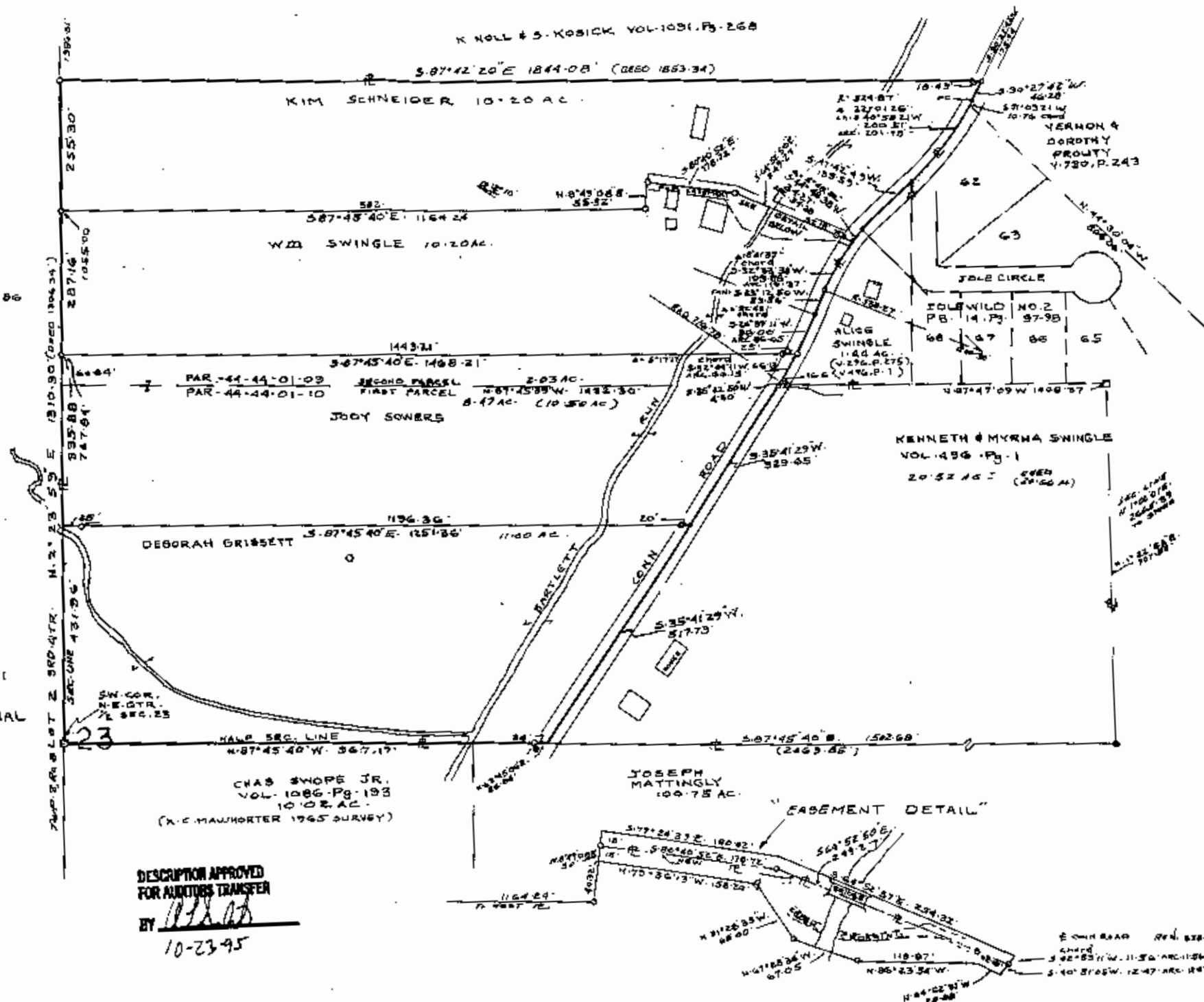
