Situated in the State of Ohio, County of Muskingum, Township of Muskingum, being part of the northwest quarter of Section 22, T2, R8 and being all of the lands now owned by Daniel A. Norris & Alecia K. Norris (DR 1071-607) and more particularly described as follows.

Beginning for reference at a point, the southeast corner of the northwest quarter of said Section 22, thence with the mid-section line, N 87°33'21" W a distance of 441.62 feet to a point in the road bed of Richvale Road (CR-3) and the principal place of beginning.

thence continuing with said mid-section line, N 87°33'21" W a distance of 103.40 feet to a point, said point being in the road bed of said Richvale Road and also being the southeast corner of the land now owned by Muskingum Valley Park District (OR 2125-802);

thence leaving said mid-section line and going with the common line of said Norris/Muskingum Valley Park District the following two (2) courses:

1. N 02°14'56" E a distance of 474.87 feet to a pipe found, passing an iron pin set at 15.00 feet;
2. S 88°21'31" E a distance of 103.41 feet to a pipe found on the northwest corner of the lands now owned by Donald F. Wagner (DR 1157-775);

thence with the common line of said Norris/Wagner, S 02°14'56" W a distance of 476.32 feet to the place of beginning, passing an axle found at 467.40 feet, containing a total of +/-1.129 acres more or less, subject to all legal highways and easements of record.

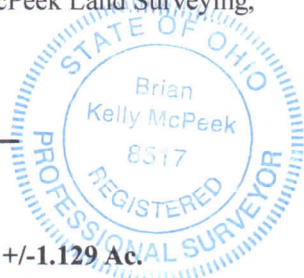

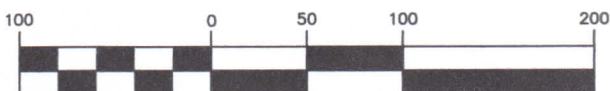
