KNOW ALL MEN BY THESE PRESENTS:

That Ronald E. and Kathy J. Pryor
hereinafter referred to as the Grantor (as used herein, Grantor includes the plural and words in the masculine include the feminine) in consideration of the sum of _____
Dollars (\$ _____) to him paid by the State of Ohio, the Grantee, the receipt whereof is hereby
acknowledged, does hereby grant, bargain, sell and convey to the said Grantee, its successors and
assigns forever, the following described real estate:

The lands herein described are situated in Section 22, Township 2N, Range 8W, Muskingum
Township, Muskingum County, State of Ohio. Being further described as follows:

PARCEL NO. 13WD

Being a parcel of land lying on the left side of the centerline of survey for Mus-60-22.70 made by
the Ohio Department of Transportation, and recorded in Plat File _____, Slot _____, of the Muskingum
County Plat Records and being located within the following described points in the boundary thereof.

Beginning at the section line of Falls Township and Muskingum Township where it intersects the
existing centerline of State Route 60, at Station 1216+91.22 as shown on the plan of Mus-60-22.70 as
mentioned above:

- thence, along a curve to the left a distance of 116.79 feet, with a radius of 3819.72 feet and whose chord
bears **N09°54'54"W** a distance of 116.79 feet, along the existing centerline of State Route 60
to a point on the existing centerline of State Route 60, being centerline station 1218+08.03 of
existing State Route 60;
- thence, **N10°47'30"W** a distance of 529.97 feet, along existing State Route 60 to a point located 0.75
feet left of centerline station 1223+37.99 of proposed State Route 60; being the **TRUE POINT
OF BEGINNING**;
- thence, **S74°56'11"W** a distance of 44.37 feet, through the lands of Ronald E. and Kathy J. Pryor
(1110/642) to a set rebar, located 45.00 feet left of centerline station 1223+34.63 of proposed
State Route 60;
- thence, **N12°52'05"W** a distance of 391.17 feet through said lands to a point on the northern property
line of Ronald E. and Kathy J. Pryor (1110/642), located 75.00 feet left of centerline station
1227+13.81 of proposed State Route 60;
- thence, **S62°57'00"E** a distance of 73.98 feet, along said property line to a point on existing State Route
60, located 10.43 feet left of centerline station 1226+79.23 of proposed State Route 60;
- thence, **S10°47'30"E** a distance of 342.23 feet to a point, being the **TRUE POINT OF BEGINNING**;

It is understood that the parcel of land described covers 0.429 acres, more or less, including
the present road which occupies 0.275 acres, more or less, and is a part of the Auditors Parcel
No. 44-48-01-18-002. All set iron pins are 5/8" x 30" rebars with yellow I.D. caps inscribed "O.D.O.T.
District 5". Bearings are based upon an assumed meridian.
