Commencing at the southwest corner of the Northeast Quarter of said Section 21; thence along the west line of a 0.50 acre parcel conveyed to Richvale Grange #1717 by deed recorded in Deed Book 158, Page 324 (now owned by William A. Doyle by deed recorded in Deed Book 1005, Page 1) north 2 degrees 12 minutes 07 seconds east 188.57 feet to an iron pin found at the northwest corner of said 0.50 acre parcel; thence along the west line of the northeast quarter of section 21 north 2 degrees 13 minutes 34 seconds east 442.94 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence continuing north 2 degrees 13 minutes 34 seconds east 321.36 feet to an iron pin; thence south 87 degrees 44 minutes 59 seconds east 650.72 feet to a point in Dresden Road; thence along said Dresden Road south 1 degree 44 minutes 59 seconds east 120.26 feet to a point; thence continuing along said Dresden Road south 10 degrees 21 minutes 57 seconds east, 206.38 feet to a point; thence leaving said road north 87 degrees 44 minutes 59 seconds west 704.05 feet to the true place of beginning, containing five (4.95) acres more or less.
