COMMENCING AT THE NORTHWEST CORNER OF SAID QUARTER TOWNSHIP 3, THENCE, SOUTH 04 DEGREES - 25 MINUTES - 50 SECONDS WEST, 2643.96 PEET TO A POINT; THENCE, SOUTH 85 DEGREES - 34 MINUTES - 10 SECONDS EAST, 2019.60 FEET TO A POINT; THENCE, SOUTH 04 DEGREES - 25 MINUTES - 50 SECONDS WEST, 106.26 FEET TO A POINT; THENCE, SOUTH 04 DEGREES - 25 MINUTES - 30 SECONDS WAST, 100.20 FEET TO A POINT; THENCE, SOUTH 85 DEGREES - 16 MINUTES - 10 SECONDS EAST, 596.91 FEET TO A POINT; THENCE, SOUTH 28 DEGREES - 25 MINUTES - 42 SECONDS EAST, 1066.15 FEET TO AN IRON PIN FOUND, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 89 DEGREES - 08 MINUTES - 10 SECONDS EAST, 75.81 FERT TO AN IRON PIN FOUND; THENCE, SOUTH 02 DEGREES - 04 MINUTES - 15 SECONDS EAST, 58.11 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 71 DEGREES - 20 MINUTES - 30 137.30 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.669 ACRES MORE OR LESS.
