

Situated in the State of Ohio, County of Muskingum, Township of Falls, Township 1 N, Range 7 W, Quarter Township 2; and Township of Muskingum, Township 2 N, Range 7 W, Quarter Township 3 and being further described as follows. Commencing at a point at the intersection of the west line of the said Range 7 and the common line between Township 1 N and Township 2 N, thence South 89° 49' 23" East, 994.00 feet along the township line to the point of beginning of the parcel herein described.

thence, North 00° 10' 37" East, 294.98 feet across G. Appleman et al (Deed Book 1093, Page 599) to a point at an iron pin - set - on the south right-of-way line of a proposed 50.00 foot wide street,  
thence, South 89° 47' 43" East, 127.93 feet along the said right-of-way line to a point of curve at an iron pin - set,  
thence, continuing along the said right-of-way line with a curve to the right (radius 189.76 feet) 147.48 feet, the chord bearing South 67° 31' 47" East, 143.80 feet to a point at an iron pin - set,  
thence, South 00° 00' 55" East, 330.23 feet across the said G. Appleman to a point at an iron pin - set - passing the township line at 240.37 feet,  
thence, North 89° 49' 23" West, 262.09 feet across the said G. Appleman to a point at an iron pin - set,  
thence, North 00° 10' 37" East, 89.63 feet across the said G. Appleman to the point of beginning,  
containing a total of 2.256 acres.

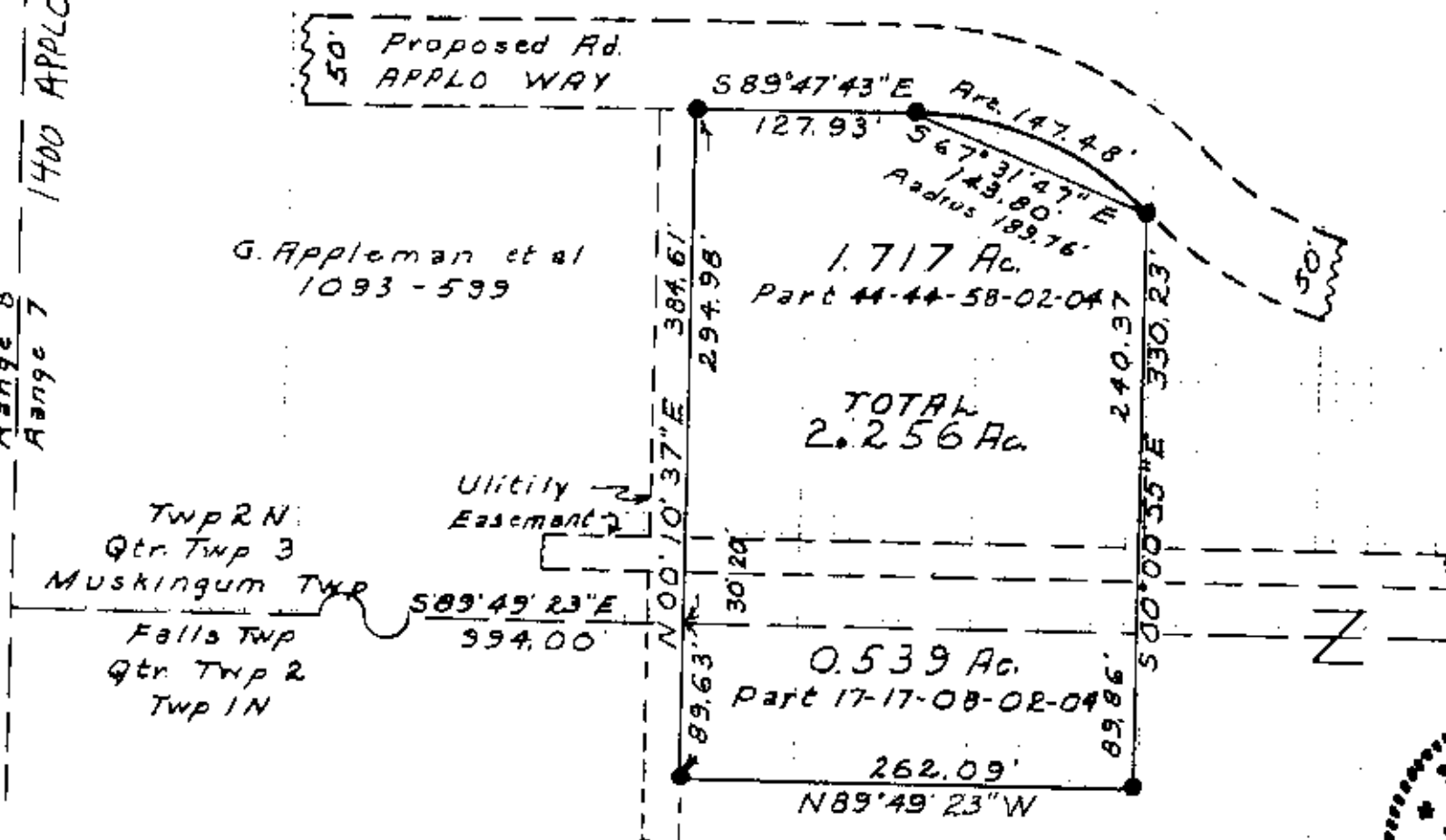

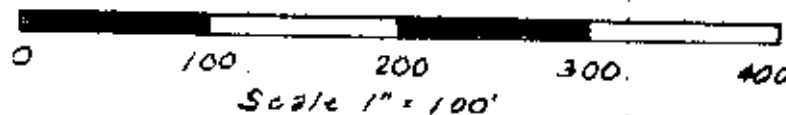
