Beginning at an iron pin set at the southwest corner of said Lot 24 of Highview Meadows Subdivision (Plat Book 13, Pg. 73); thence north (the base of bearings for this description is plat book 13, page 73) along the west line of said Lot 24 and the east line of a 0.50 acre parcel owned by James and Judith Tyson (Vol. 715, Pg. 335) a distance of 210.00 feet to an iron pin found; thence east along the north line of said Lot 24 and the south line of Lot 16 owned by Bruce and Colleen Davenport (Vol. 1041, Pg. 51) a distance of 47.50 feet to an iron pin set; thence south 210.00 feet to an iron pin set on the south line of said Lot 24 and the north line of Bellview Drive; thence west along the south line of said Lot and the north line of said road 47.50 feet to the place of beginning containing twenty three hundredths (0.23) of an acre.

Subject to the restrictions of Highview Meadows Subdivision in Plat Book 13, Page 73.

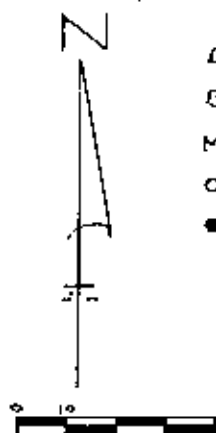
