DESCRIPTION OF SURVEY FOR DEBORAH S. PETHTEL

Situated in the State of Ohio, County of Muskingum, Township of Muskingum, Third Quarter Township, Township #2, Range #7 of the U.S. Military District:

Being all of prior deed reference Vol. 521, Page 431, all of County Auditor's parcel #44-00636, and more particularly described as follows:

Beginning at an iron pipe (found) at the most Northerly corner of lot #3 in Terrace Shore #3 as recorded in Plat Book 14, Page 44 of said County's records: thence along the Northwest line of said lot #3 S 44° 54' 17" W (140.00) feet to an iron pipe (found) at the most Westerly corner of said lot #3; thence along the Northeast line of lot #19 of said Terrace Shore #3 N 45° 05' 53" W (120.00) feet to an iron pin (set) at the most Southerly corner of lot #2 of said Terrace Shore #3; thence along the Southeast line of said lot #2 N 44° 54' 17" E (140.00) feet to an iron pin (found) at the most Easterly corner of said lot #2; thence along the right of way line for West Shore Drive (Twp. Rd.#1436) S 45° 05' 53" E (120.00) feet to the place of beginning containing (0.386) acres.

The iron pin (set) is a 5/8" rebar 36" in length with an aluminum identification cap. Bearings within this description are based on the Northwest line of said lot #3 of Terrace Shore #3 being S 44° 54' 17" W.




SURVEY PLAT FOR D. PETHTEL


