DESCRIPTION OF SURVEY FOR GREG CLOSSMAN

Situated in the State of Ohio, County of Muskingum, Township of Muskingum:

Being part of the third Quarter Township, Township #2, Range #7, of the US Military District, being part of the Roger D. Graham property described in deed reference Deed Book Volume 678, Page 70 of said county's deed records, known as Muskingum County Auditor's Parcel Number 44-66-02-13-000, and more particularly described as follows;

Beginning at an iron pipe (found) at the Southwest corner of Lot #28 of Terrace Shore No. 3 recorded in Plat Book 14, Page 44, being on North right of way line for Dur-Mel Drive (Township Road #1431) platted as part of Terrace Shore No. 2 recorded in Plat Book Volume 13, Page 17, also being the common corner of the Greg Clossman property described in deed reference Deed Book Volume 1058, Page 190 and for said Graham property;

- #1- thence S 50 55 00 W 180.89 feet along the chord for a curve to the left, having a radius of 496.93 feet and arc length of 181.90 feet, said curve being said North right of way and along a line of said Graham property to an iron pin (set);
- #2- thence N 50 42 50 W 197.04 feet leaving said right of way and through said Graham property to an iron pipe (found) at a common corner for said Clossman and Graham properties, also being on the East line of the Daniel and Patricia Lane property described in deed reference Deed Book 623, Page 70;
- #3- thence S 87 54 10 E 293.11 feet along the common line for said Clossman and Graham properties to the place of beginning, containing 0.38 acres.

The bearings within the description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.#6885).

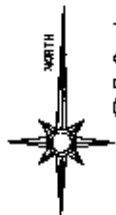

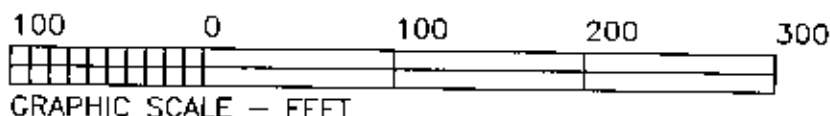

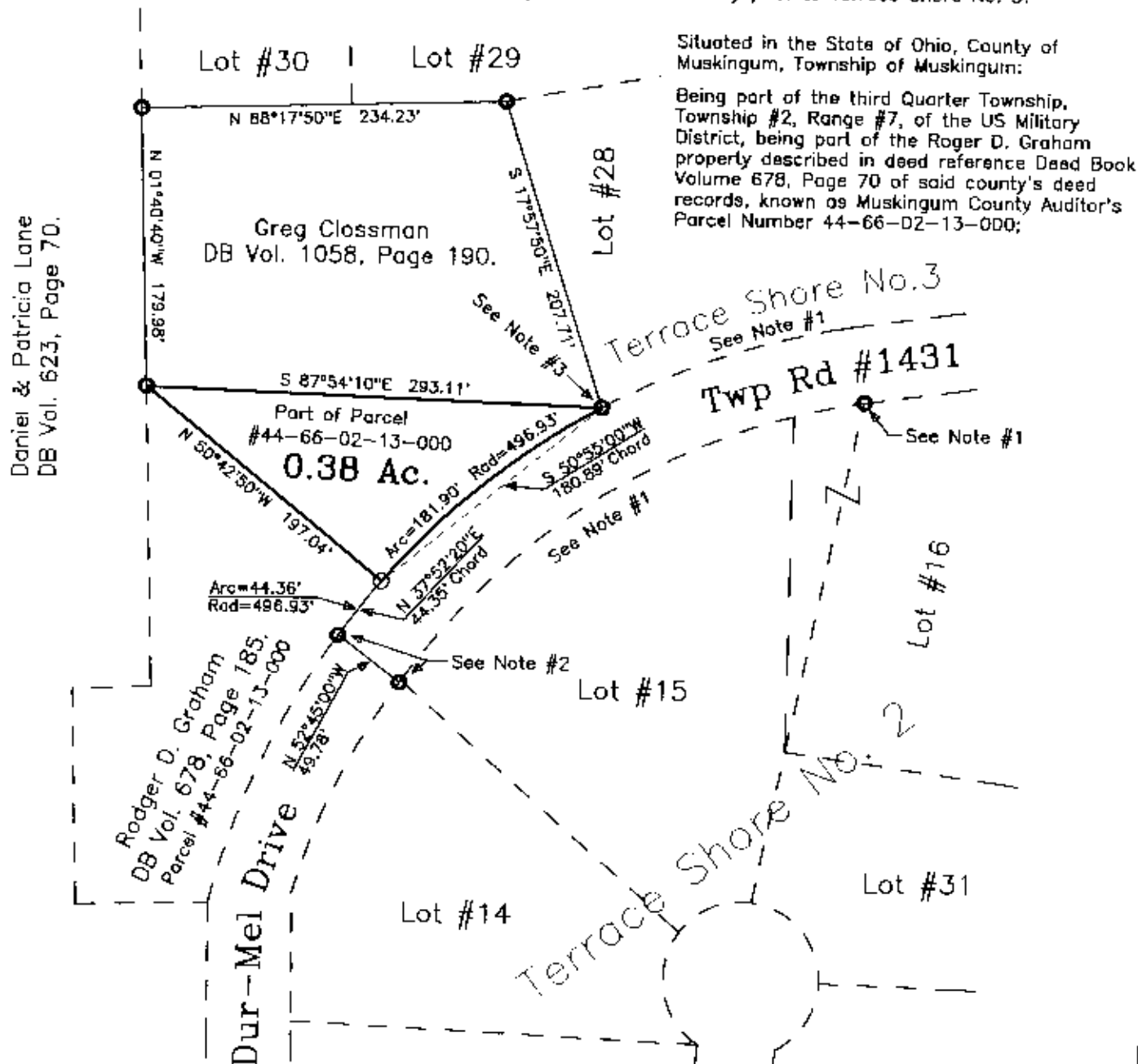

- Note #1 - Curve data along Dur-Mel Drive recorded within previous deeds and shown on the plat of Terrace Shore No. 2 are not consistent with bearings and distances recorded as lot line or deed lines.  
Note #2 - Pipes considered original to Terrace Shore No. 2 are consistent in material, size, condition and placement with other original monuments found within Terrace Shore No. 2.  
Note #3 - Pipe (capped with a threaded pipe cap) set by John Marshall survey prior to Terrace Shore No. 3.
