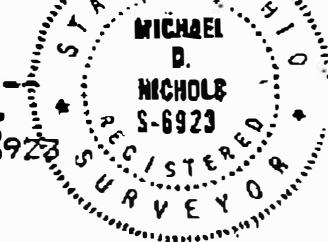
COMMENCING AT AN EXISTING STONE AT THE NORTHEAST CORNER OF THE NORTHEAST QUARTER OF SECTION 11; THENCE WITH THE NORTH LINE OF THE SAID NORTHEAST QUARTER NORTH 88 DEGREES 57 MINUTES 56 SECONDS WEST 1089.23 FEET TO AN EXISTING IRON PIN (1 INCH PIPE) AT THE NORTHEAST CORNER OF A 16.045 MORE OR LESS ACRE TRACT CONVEYED TO R. L., SR. AND E. WILSON BY DEED RECORDED IN VOLUME 976, PAGE 180 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE LEAVING THE SAID NORTH LINE AND WITH THE EAST LINE OF THE SAID WILSON TRACT SOUTH 03 DEGREES 49 MINUTES 00 SECONDS WEST 308.91 FEET TO AN EXISTING RAILROAD SPIKE IN THE CENTER OF COUNTY ROAD 33 (BAGLEY ROAD), SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HERE INTENDED TO BE DESCRIBED, PASSING AN EXISTING IRON PIN (1 INCH PIPE) AT 293.91 FEET; THENCE WITH THE SAID CENTER LINE NORTH 87 DEGREES 04 MINUTES 19 SECONDS EAST 64.18 FEET TO A POINT; THENCE CONTINUING WITH THE SAID CENTERLINE SOUTH 85 DEGREES 40 MINUTES 49 SECONDS EAST 34.58 FEET TO A POINT; THENCE LEAVING THE SAID ROAD SOUTH 00 DEGREES 14 MINUTES 53 SECONDS WEST 732.40 FEET TO AN IRON PIN SET, PASSING IRON PINS SET AT 25.00 FEET AND 386.14 FEET; THENCE NORTH 89 DEGREES 45 MINUTES 07 SECONDS WEST 300.00 FEET TO AN IRON PIN SET ON THE EAST LINE OF A TRACT CONVEYED TO R. M. AND H. M. JONES BY DEED RECORDED IN VOLUME 565, PAGE 524 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE NORTH 00 DEGREES 14 MINUTES 53 SECONDS EAST 714.05 FEET ALONG THE SAID JONES TRACT TO A POINT IN THE CENTER OF COUNTY ROAD 33 ON THE SOUTH LINE OF THE ABOVE MENTIONED WILSON TRACT, PASSING AN EXISTING IRON PIN (AXLE) AT 299.46 FEET AND AN EXISTING IRON PIN (5/8 INCH REBAR) AT 689.05 FEET; THENCE WITH THE SAID SOUTH LINE OF THE WILSON TRACT NORTH 85 DEGREES 21 MINUTES 10 SECONDS EAST 202.16 FEET TO THE PLACE OF BEGINNING.

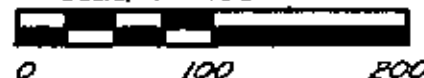
