Iron pins set are No. 5 reinforced bars 30 inches long with plastic ID caps.

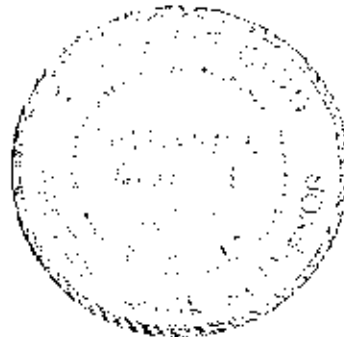

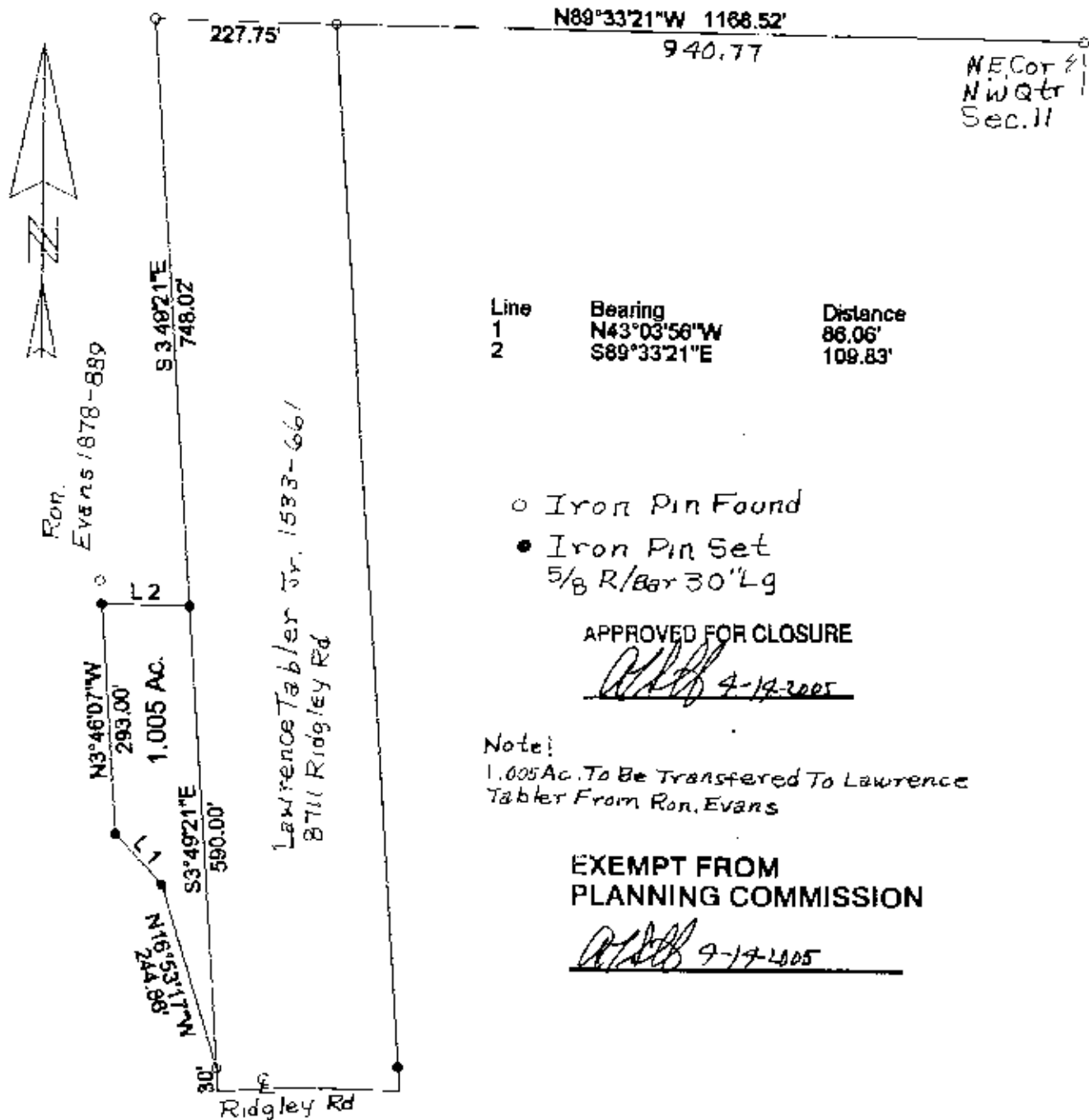
