Being a part of the northwest quarter of section 1, north half of quarter township 1, township 17, range 15, bounded and described as follows:

Beginning at the northwest corner of said northwest quarter of section 1; thence south 79 degrees 16 minutes 18 seconds east along Ford Road a distance of 136.30 feet to a point; thence south 55 degrees 58 minutes 48 seconds east along said road a distance of 335.26 feet to a point; thence south 53 degrees 09 minutes 56 seconds east along said road a distance of 178.61 feet to a point; thence south 24 degrees 13 minutes 10 seconds east along said road a distance of 360.61 feet to a point; thence south 14 degrees 54 minutes 53 seconds east along said road a distance of 250.12 feet to a point at the northeasterly corner of lands now or formerly owned by H. Goins and recorded in deed book 695, page 194 of the deed records of said county; thence north 73 degrees 39 minutes 16 seconds west along said Goins line a distance of 84.57 feet to an existing iron pin and passing through an existing iron pin at 24.06 feet; thence south 16 degrees 09 minutes 48 seconds east along said line a distance of 320.41 feet to an existing iron pin; thence north 76 degrees 37 minutes 58 seconds east along said line a distance of 100.00 feet to an existing iron pin; thence south 16 degrees 09 minutes 48 seconds east along said line a distance of 40.00 feet to an existing iron pin; thence north 76 degrees 37 minutes 58 seconds east along said line a distance of 205.45 feet to an existing iron pin; thence north 22 degrees 55 minutes 24 seconds east along said line a distance of 90.64 feet to an existing iron pin; thence north 72 degrees 50 minutes 29 seconds east along said line a distance of 191.52 feet to an existing iron pin; thence south 25 degrees 23 minutes 21 seconds east along said line a distance of 408.52 feet to an existing iron pin; thence south 38 degrees 54 minutes 40 seconds east along said line a distance of 509.25 feet to an existing iron pin; thence north 86 degrees 24 minutes 47 seconds west along the northerly line of lands now or formerly owned by F. White and recorded in deed book 521, page 957 of the deed records of said county a distance of 1820.00 feet to an iron pin; thence north 00 degrees 40 minutes 56 seconds east along the section line a distance of 1653.92 feet to the true place of beginning and passing through an iron pin at 1628.92 feet, containing Thirty Six and Twenty Nine (36.29) hundredths acres more or less.

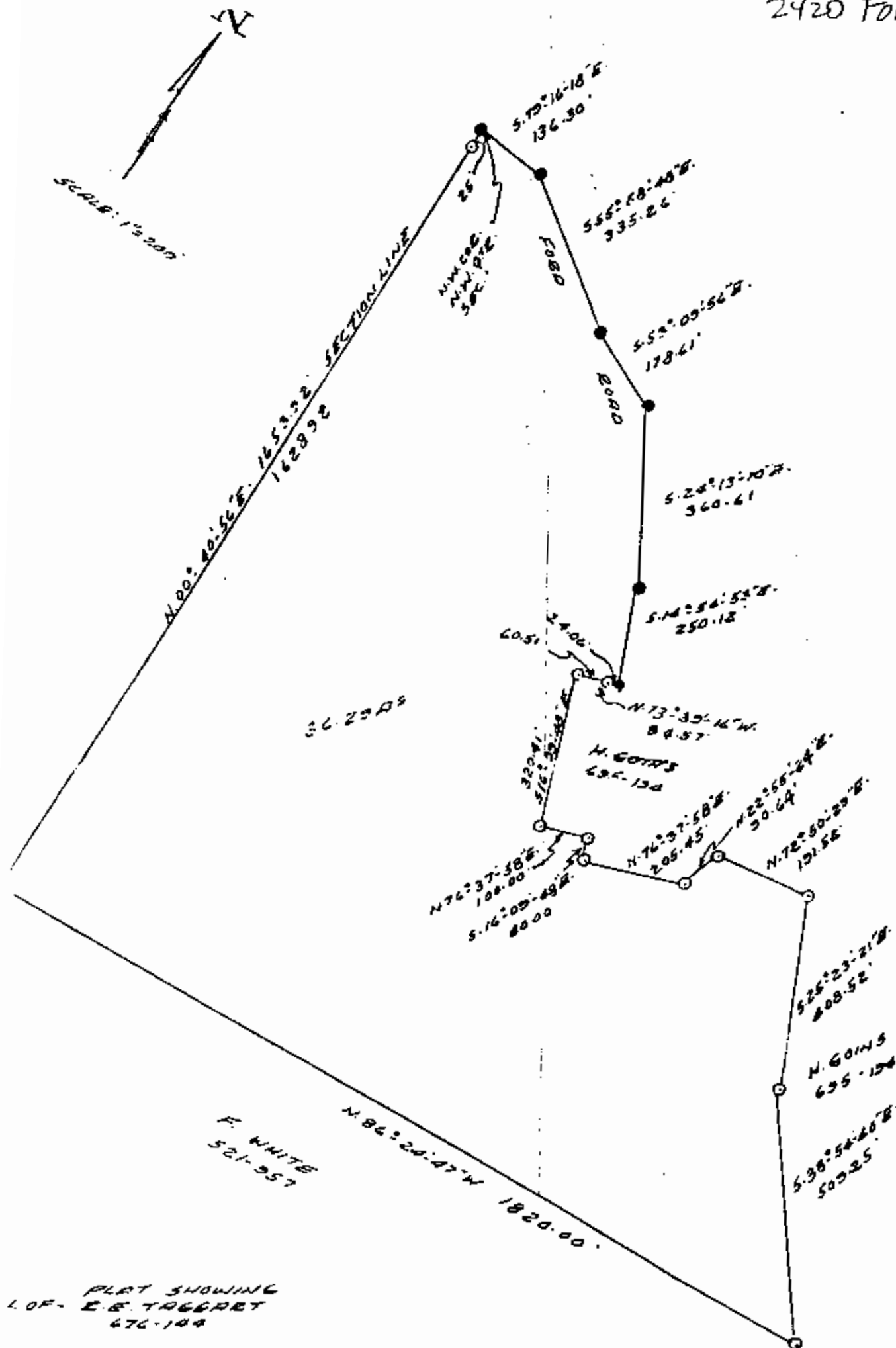
