## DESCRIPTION OF SURVEY FOR COUNTRYTYME GROVE CITY LTD JOB#1467-PAR2

Being part of the Southwest Quarter, of Section #1, Township #17, Range #15, of the Congress Lands East of the Scioto River, **being part of** the CountryTyme Grove City, Ltd. property recorded in Official Record Volume 1997, Page 849 of said county's deed records, further being known as Muskingum County **Auditor's Parcel Number 47-04-01-29-006**, and more particularly described as follows;

Commencing at a stone (found) marked at the common corner for Sections #1, #2, #11, and #12 of said Township and Range;

- THENCE South 86 degrees 49 minutes 30 seconds East 1600.55 feet along the common line for said Sections #1 & #12 to an iron pin (set) at the place of beginning for the property herein intended to be described, passing iron pins (found) at 734.19 feet and 916.86 feet, also passing an iron pin (found) at the common Northern corner for the East and West Halves of the Northwest Quarter of said Section #12 at 1292.49 feet;
- #1- THENCE North 02 degrees 47 minutes 25 seconds East 799.52 feet into said Section #1 and through said CountryTyme property to an unmarked point in the centerline of Opera Road (Township Road #277), passing iron pins (set) at 200.00 feet, 400.00 feet, 600.00 feet, and 769.52 feet;
- **#2- THENCE South 47 degrees 59 minutes 35 seconds East 112.82 feet** along said road and common line for said CountryTyme property and for the Lyle Plummer property recorded in Official Record Volume 1655, Page 779, to an unmarked point;
- #3- THENCE South 54 degrees 15 minutes 15 seconds East 98.43 feet along said road to an unmarked point;
- #4- THENCE South 02 degrees 47 minutes 25 seconds West 675.79 feet leaving said road and through said CountryTyme property to an iron pin (set) on the common line for said Sections #1 & #12, passing iron pins (set) at 30.00 feet, 75.79 feet, 275.79 feet, and 475.79 feet;
- **#5-** THENCE North 86 degrees 49 minutes 30 seconds West 170.00 feet along said Section line to the place of beginning, containing 2.87 acres, of which 0.07 acres are within the right of way for Opera Road (Township Road #277).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
