LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Newton, and being part of the southwest quarter of Section 1, Township 17, Range 15, and being all those lands intended to be described in Deed Volume 1067, page 486; being further bounded and described as follows:

Beginning at an iron pin found at the southeast corner of the southwest quarter of Section 1, said point being in the center of Opera Road, thence, south 89 degrees – 47 minutes – 34 seconds west, 574.61 feet along the south line of said Section 1 to an iron pin set, passing iron pins found at 20.00 feet and 531.92 feet;

Thence, leaving said Section line, north 00 degrees – 32 minutes – 53 seconds west, 522.33 feet to a point in the center of Opera Road, passing an iron pin set at 502.33 feet;

Thence, along said road, the following four (4) courses and distances:

1. south 55 degrees – 12 minutes – 17 seconds east, 345.45 feet to a point;
2. south 51 degrees – 42 minutes – 28 seconds east, 259.32 feet to a point;
3. south 52 degrees – 27 minutes – 48 seconds east, 116.81 feet to a point;
4. south 00 degrees – 08 minutes – 39 seconds west, 91.24 feet to the ***point of beginning***, and ***containing 4.134 acres more or less.***

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Subject to all legal highways and easements, whether recorded or implied.

Bearings described herein are based upon assumed azimuth and to be used for angle purposes only.

Being all of Auditor's Parcel #47-04-01-34-000.

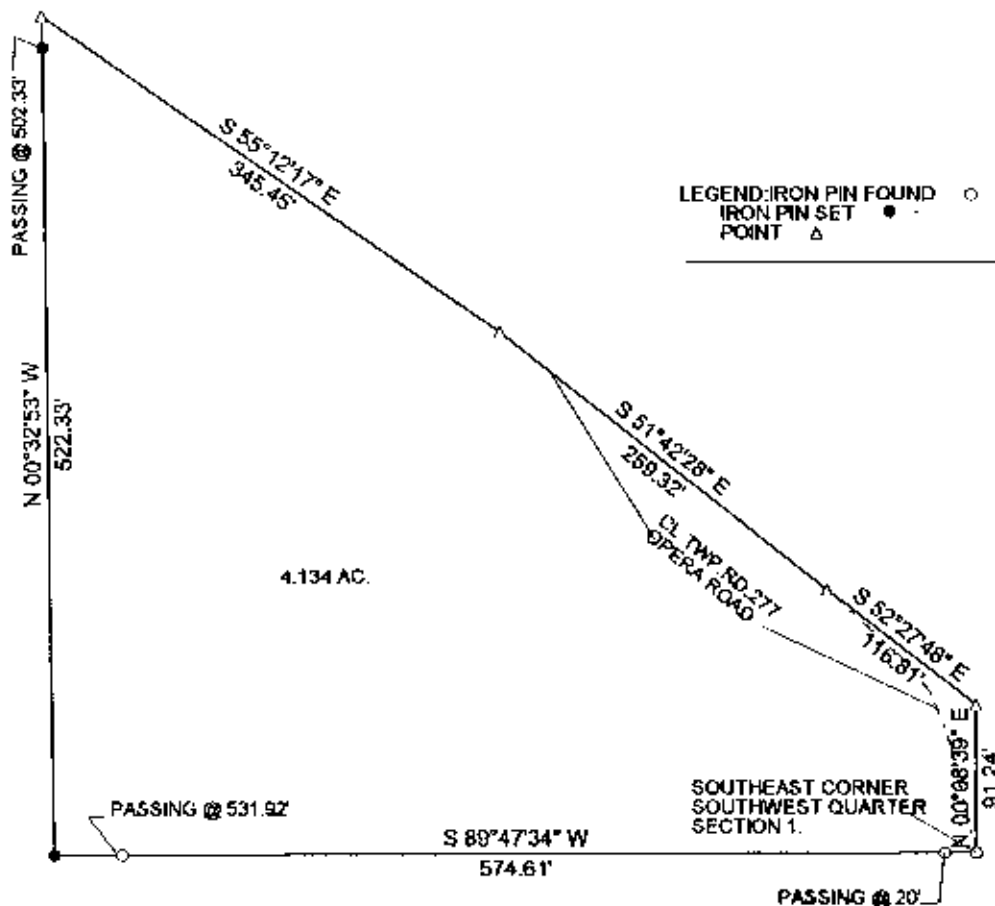
