

DESCRIPTION OF SURVEY FOR BETTY (GILL) WILLIAMSON JOB#1007-1

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southeast Quarter, of Section #5, Township #15, Range #14, of the Congress Lands East of the Scioto River, further being part of the E J Gill property recorded in deed reference Deed Book Volume 341, Page 199, known as Muskingum County Auditor's Parcel Number 47-08-01-01-000, and more particularly described as follows;

Commencing at an iron pin (found) at the Southwest corner of said Southeast Quarter, of Section #5; **thence N 03 16 50 E 610.12 feet** along the common line for the Southeast and Southwest Quarters of said Section #5, to the Northwest corner of the M J Gill property recorded in deed reference Deed Book Volume 1064, Page 31, also being the place of beginning for the property herein intended to be described, from which an iron pin (found) bears for reference **N 86 44 30 W 0.11 feet**;

- #1- **thence N 03 16 50 E 689.90 feet** along said Quarter Section line to the Northeast corner of the J Campbell property recorded in deed reference Deed Book Volume 1046, Page 31, also being the Southeast corner of the J Campbell property recorded in deed reference Deed Book Volume 1518, Page 665, from which an iron pin (found) for reference bears **S 77 13 30 W 0.47 feet**;
- #2- **thence S 84 45 00 E 881.94 feet** through said E J Gill property to an iron pin (set) on the West line of the D & C Cowden property recorded in deed reference Deed Book Volume 758, Page 340;
- #3- **thence S 19 45 10 W 276.52 feet** along said Cowden property to an iron pin (found) at a common corner for said Cowden property and for the M J Gill property recorded in deed reference Deed Book Volume 1114, Page 164;
- #4- **thence S 32 53 20 W 453.39 feet** along a line for said M J Gill property recorded in deed reference Deed Book Volume 1114, Page 164 to an iron pin (found) at the Northeast corner of said M J Gill property recorded in deed reference Deed Book Volume 1046, Page 31;
- #5- **thence N 86 44 30 W 579.00 feet** along the North line of said M J Gill property recorded in deed reference Deed Book Volume 1046, Page 31 to the place of beginning **containing 11.69 acres**.

The bearings within this description are based on State Plane Coordinate Grid derived from a Solar Observation (local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).

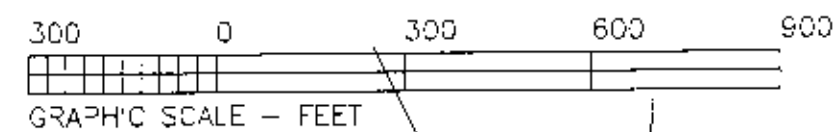

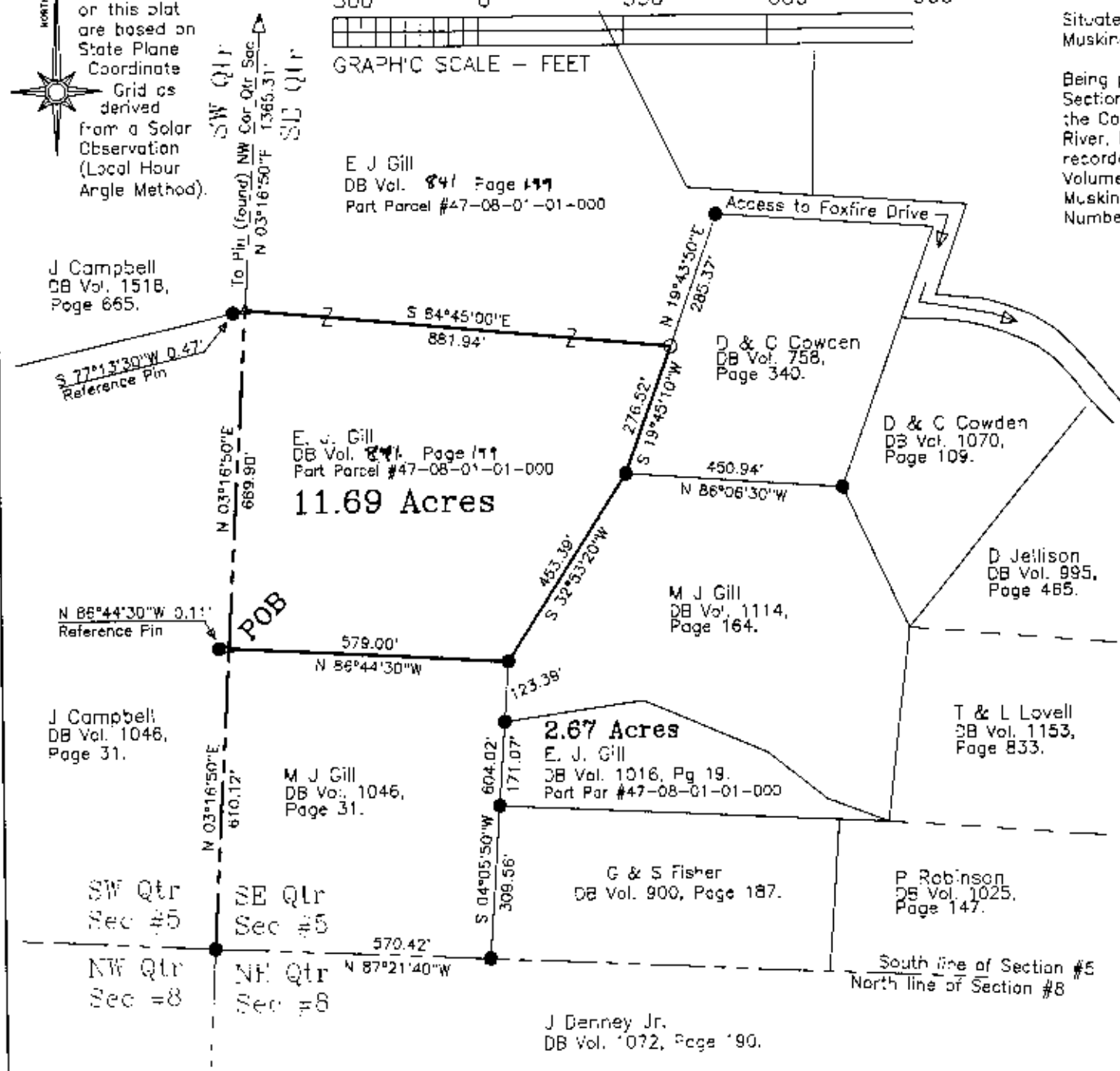
