

## DESCRIPTION OF SURVEY FOR BETTY ( GILL) WILLIAMS

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southeast Quarter, of Section #5, Township #15, Range #14, of the Congress Lands East of the Scioto River, further being part of the E J Gill properly recorded in deed reference Deed Book Volume 841, Page 199, known as Muskingum County Auditor's Parcel Number 47-08-01-01-000, and more particularly described as follows;

Commencing at an iron pin (found) at the center of Section #5; **thence S 87 16 30 E 303.65 feet** along the common line for the Northeast and Southeast Quarters of Section #5, also being the line between Springfield and Newton Townships, of said County to an iron pin (set) at the place of beginning for the property herein intended to be described;

- #1- **thence S 87 16 30 E 1331.02 feet** continuing along said Quarter Section line to an iron pin (set);
- #2- **thence S 02 44 50 W 720.07 feet** into said Southeast Quarter of Section #5, and through said E J Gill property to an iron pin (set) on the North line of the C Campbell property recorded in deed reference Deed Book Volume 920, Page 310;
- #3- **thence N 70 17 10 W 260.82 feet** along the North line of said Campbell property to an iron pin (set) at the Northwest corner of said Campbell property;
- #4- **thence S 19 35 20 W 463.02 feet** along the West line of said Campbell property to an iron pin (found) on the North line of a 50 foot wide easement recorded in deed reference Deed Book Volume 1124, Page 238;
- #5- **thence N 86 11 10 W 100.00 feet** along the North line of said easement and through said E J Gill property to an iron pin (found) at the Southeast corner of the J Wheeler property recorded in said Deed Book Volume 1512, Page 951;
- #6- **thence N 00 30 40 E 700.80 feet** along the East line of said Wheeler property to an iron pin (found) at the Northeast corner of said Wheeler property;
- #7- **thence N 88 04 40 W 621.44 feet** along the North line of said Wheeler property to an iron pin (found) at the Northwest corner of said Wheeler property;
- #8- **thence N 24 03 00 W 440.72 feet** through said E J Gill property to the place of beginning **containing 15.97 acres.**

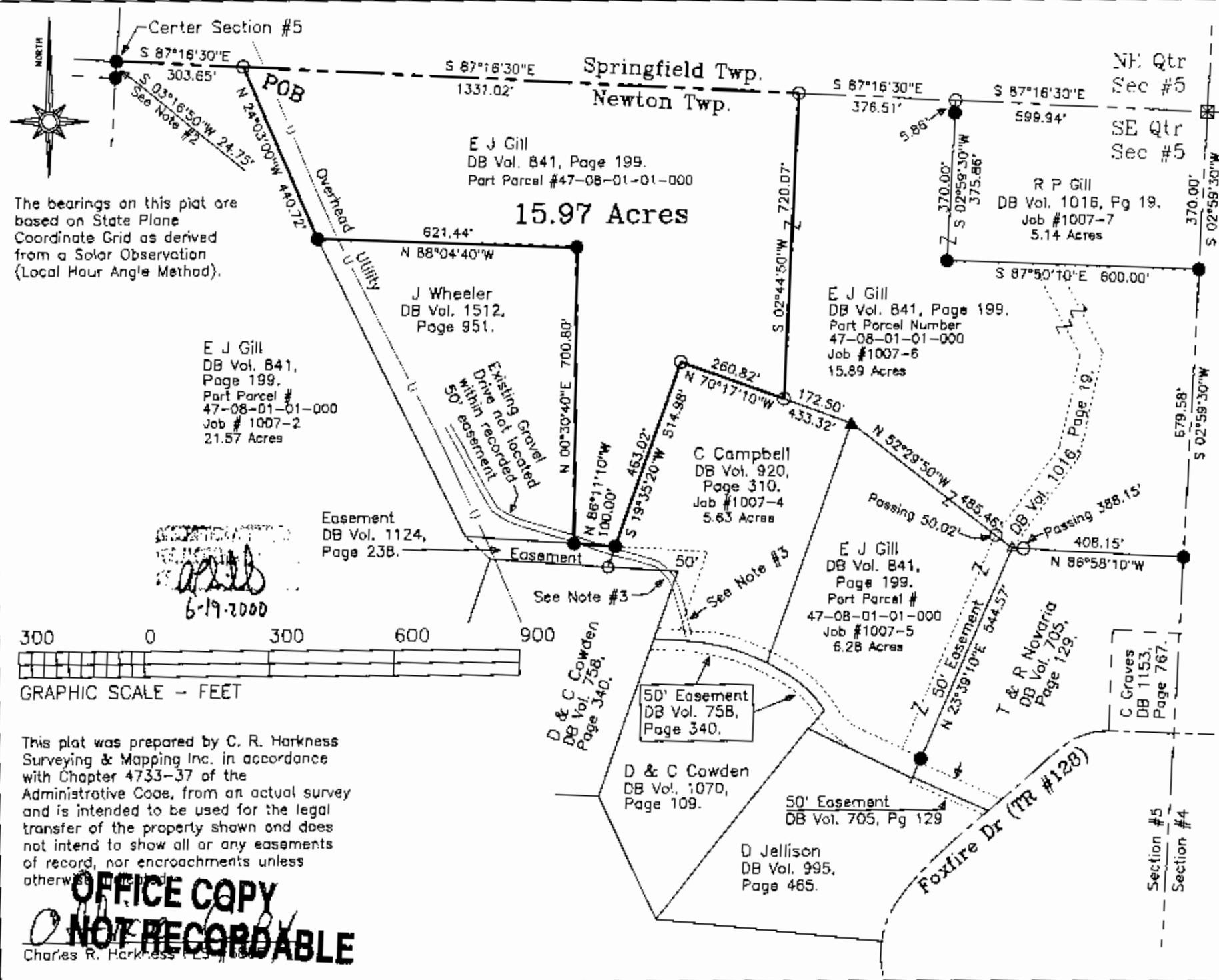
