

DESCRIPTION OF SURVEY FOR  
CLARK R CAMPBELL AND BETHANY J CAMPBELL  
JOB#1874-5

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southeast Quarter, of Section 5, of Township 15, Range 14, of the Congress Lands East of the Scioto River, **being part of** the Clark R Campbell and Bethany J Campbell property recorded in Official Record Volume 1554, Pages 461, 464, of said county's deed records, further to be known as Muskingum County **Auditor's Parcel Number 47-08-01-01-009**, and more particularly described as follows;

Commencing at an iron pin (found) at the Center of Section 5:

- TIE-1 THENCE South 87 degrees 16 minutes 35 seconds East 303.65 feet** along the common line for the Southeast and Northeast Quarters of Section 5 to an iron pin (found) at a common corner for said Campbell property and the Clark R Campbell and Bethany J Campbell property recorded in Official Record Volume 1880, Page 461;
- TIE-2 THENCE South 24 degrees 03 minutes 00 seconds East 440.72 feet** along said Campbell properties to an iron pin (found) at a corner of the Starr Jinkens and Mark Jinkens property recorded in Official Record Volume 1777, Page 698;
- TIE-3 THENCE South 88 degrees 04 minutes 40 seconds East 621.44 feet** continuing along said Campbell and Jinkens properties to an iron pin (found);
- TIE-4 THENCE South 00 degrees 30 minutes 40 seconds West 213.24 feet** along said Campbell and Jinkens properties to an iron pin (set) at the place of beginning for the property herein intended to be described;
- #1- THENCE South 78 degrees 39 minutes 35 seconds East 300.00 feet** through said Campbell properties to an iron pin (set);
- #2- THENCE South 13 degrees 19 minutes 35 seconds West 450.00 feet** continuing through said Campbell properties to an iron pin (set);
- #3- THENCE North 76 degrees 26 minutes 30 seconds West 200.00 feet** continuing through said Campbell property to an iron pin (set) on the East line of said Jinkens property;
- #4- THENCE North 00 degrees 30 minutes 40 seconds East 450.00 feet** along said Campbell and Jinkens properties to the place of beginning **containing 2.56 acres.**

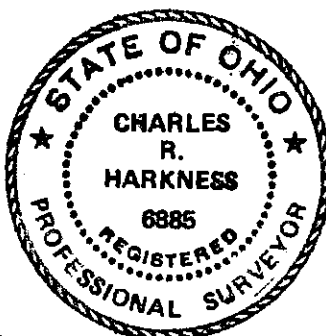
**Acreage Breakdown**

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from Solar Observations (Local Hour Angle Method). Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

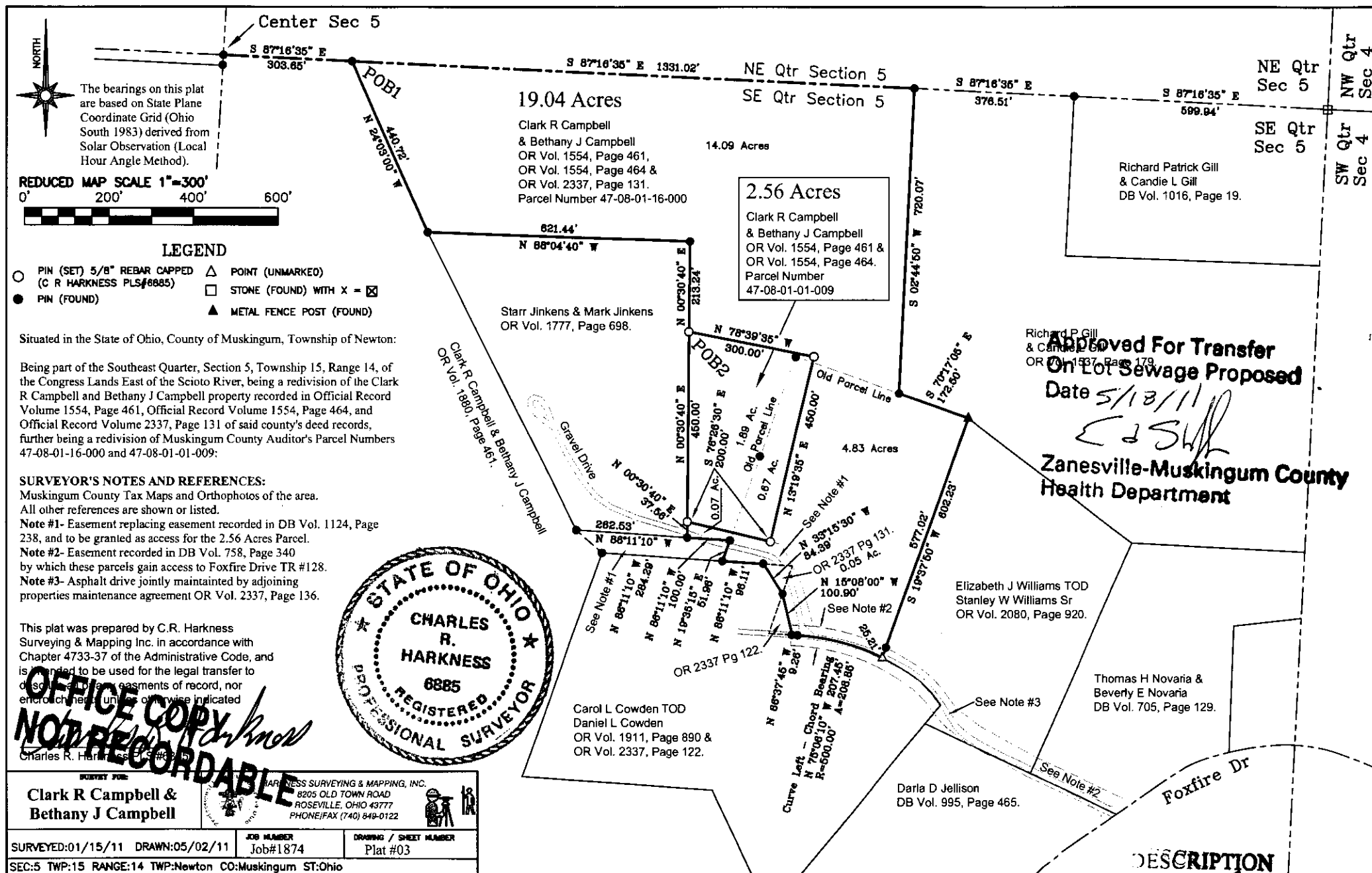
