

DESCRIPTION OF SURVEY FOR JACQUELINE CAMPBELL

JOB#1750-3

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of Southwest Quarter, of Section #5, of Township #15, Range #14, of the Congress Lands East of the Scioto River **being part of the Jacqueline Campbell property** recorded in Official Record Volume 2099, Page 668 of said county's deed records, further being part of Muskingum County **Auditor's Parcel Numbers 47-08-01-05-001 and 47-08-01-06-000**, and more particularly described as follows:

Beginning at an iron pin (found) at the Southeast and Southwest Quarters of Section #5 and the Northeast and Northwest Quarters of Section #8;

- #1- **THENCE North 87 degrees 22 minutes 55 seconds West 2499.53 feet** along the common line for Sections #5 and #8 to an unmarked corner in the centerline of Stine Road (Township Road #276), passing an iron pin (set) at 2470.00 feet;
- #2- **THENCE North 07 degrees 32 minutes 45 seconds East 284.17 feet** into said Southwest Quarter of Section #5, and along said road to an unmarked point;
- #3- **THENCE North 06 degrees 20 minutes 15 seconds East 167.45 feet** continuing along said road to an unmarked point;
- #4- **THENCE North 03 degrees 54 minutes 30 seconds East 200.27 feet** continuing along said road to an unmarked point at the Southwest corner of a 7.15 Acre Parcel surveyed from said Campbell property;
- #5- **THENCE South 88 degrees 03 minutes 10 seconds East 209.88 feet** leaving said road and along a line of said 7.15 Acre Parcel to an iron pin (set), passing iron pins (set) at 37.49 feet and 125.84;
- #6- **THENCE South 73 degrees 21 minutes 45 seconds East 1068.00 feet** continuing along said 7.15 Acre Parcel to an iron pin (set);
- #7- **THENCE North 06 degrees 14 minutes 30 seconds West 550.94 feet** continuing along said 7.15 Acre Parcel to an iron pin (found) at a common corner for said Campbell property and for the Matthew and Angela McCandlish property recorded in Official Record Volume 1641, Page 48 and for the Bert Hartman property recorded in Official Record Volume 2005, Page 432;
- #8- **THENCE South 87 degrees 04 minutes 05 seconds East 433.87 feet** along said Campbell and McCandlish properties to an iron pin (found);
- #9- **THENCE North 02 degrees 55 seconds 55 minutes East 399.99 feet** continuing along said Campbell and McCandlish properties to an iron pin (found), also being a common corner for the Raymond Dodson property recorded in Deed Book Volume 1111, Page 417, and for a 29.57 Acre Parcel surveyed from said Campbell property;
- #10- **THENCE South 86 degrees 42 minutes 25 seconds East 878.16 feet** along the South line of said 29.57 Acre Parcel to an iron pin (set) on the common line for the Southeast and Southwest Quarters Section #5;
- #11- **THENCE South 03 degrees 17 minutes 35 seconds West 1325.88 feet** along said Quarter Section line to the place of beginning **containing 50.51 acres**, of which 0.30 acres are within the right of way for Stine Road (Township Road #276), passing an iron pin (found) at 715.76 feet.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.#6885).

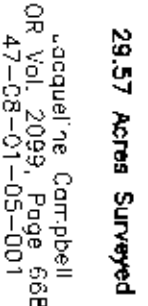

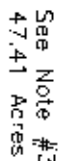
