Being a Part of the Southwest Quarter of Section Four Township Fifteen (15), Range Fourteen (14) and part of property now owned by Glenna M. McClland and Recorded in Deed Book 863, Page 11 of the Muskingum County Deed Records bounded and described as follows:

Commencing at an existing iron pin at the southeast corner of said southwest quarter of section 4; thence north 86 degrees 40 minutes 46 seconds west ( the basis of bearings for this description true astronomic north) along the south line of said southwest quarter of section 4 a distance of 816.75 feet to an iron pin set at the southeast corner of the grantor herein, Glenna M. McClland Deed Book 863, Page 11 and the southwest corner of a parcel owned by Roger Nelson and Recorded in Deed Book 620, Page 208 of the Muskingum County Deed Records said iron pin is the true place of beginning for the following described parcel; thence continuing north 86 degrees 40 minutes 46 seconds west along the south line of said southwest quarter of section 4 a distance of 521.16 feet to an iron pin set; thence north 23 degrees 21 minutes 27 seconds east 500.97 feet to a railroad spike in the center of Foxfire Drive ( Twp Rd. 128) and passing through an iron pin at 480.85 feet; thence south 60 degrees 23 minutes 36 seconds east along the center of said road 386.22 feet to a railroad spike; thence south 2 degrees 42 minutes 12 seconds west along the east line of said grantor herein and the west line of said Roger Nelson parcel 299.63 feet to the true place of beginning and passing through an iron pin at 22.43 feet containing four and no hundredths (4.00) acres.

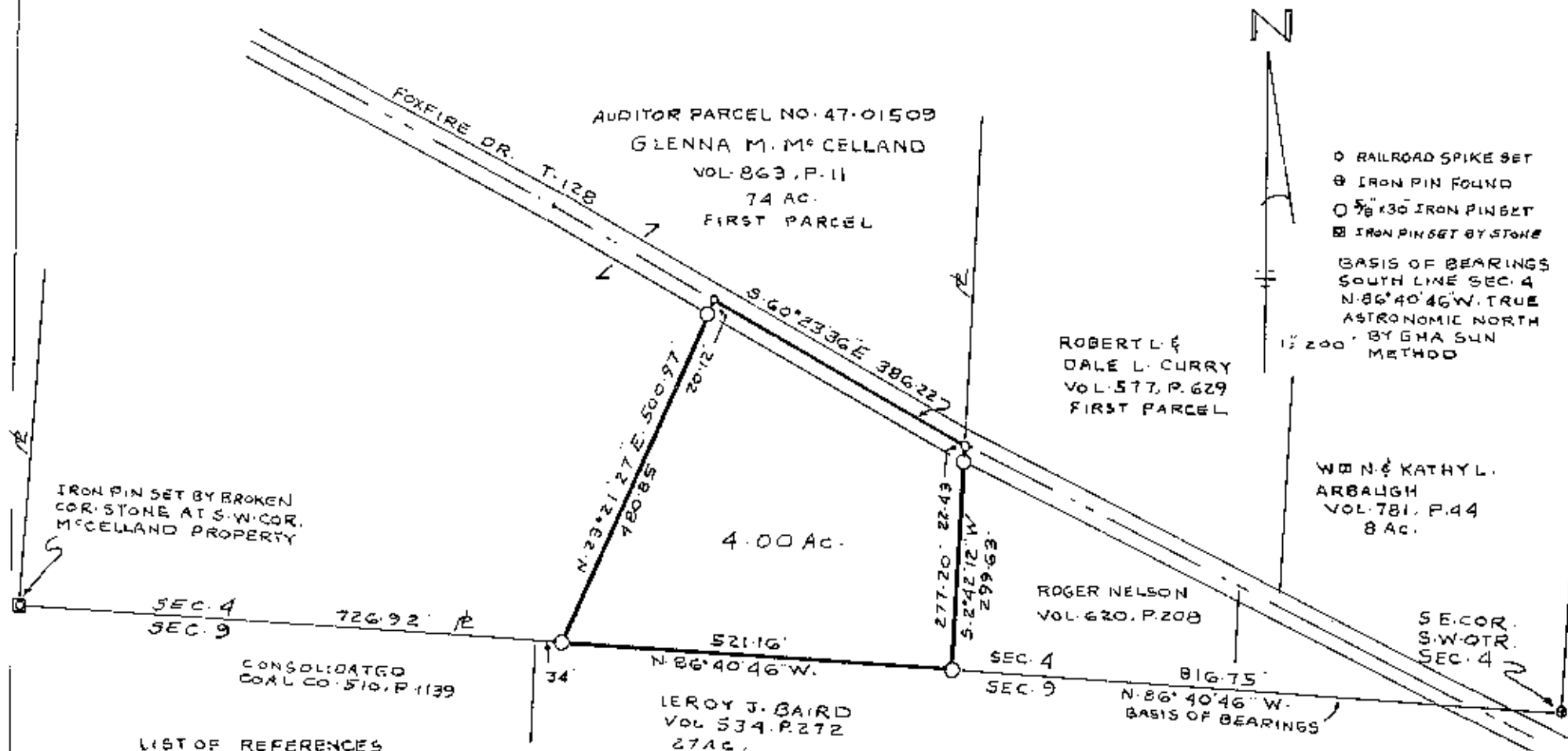
