COMMENCING AT AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION 4; THENCE NORTH 89 DEGREES 31 MINUTES 02 SECONDS WEST 493.34 FEET ALONG THE SOUTH LINE OF SECTION 4 TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED, SAID POINT BEING NORTH 00 DEGREES 00 MINUTES 00 SECONDS EAST 4.16 FEET FROM AN EXISTING IRON PIN (3/4 INCH ID PIPE); THENCE CONTINUING WITH THE SOUTH LINE OF SAID SECTION 4, NORTH 89 DEGREES 31 MINUTES 02 SECONDS WEST 323.39 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE SOUTHEAST CORNER OF A 4.00 ACRE TRACT CONVEYED TO RANDY AND JERYL STARNER BY DEED RECORDED IN VOLUME 947, PAGE 108 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE WITH THE EAST LINE OF THE SAID STARNER TRACT, NORTH 00 DEGREES 08 MINUTES 04 SECONDS WEST 299.63 FEET TO A POINT IN TOWNSHIP ROAD 128 (FOX FIRE DRIVE), PASSING AN IRON PIN SET AT 277.20 FEET; THENCE LEAVING THE SAID STARNER EAST LINE SOUTH 66 DEGREES 23 MINUTES 23 SECONDS EAST 407.37 FEET TO A POINT IN THE SAID ROAD; THENCE LEAVING THE SAID ROAD, SOUTH 19 DEGREES 27 MINUTES 33 SECONDS ~~(EAST)~~ 147.63 FEET TO THE PLACE OF BEGINNING, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 15.84 FEET.

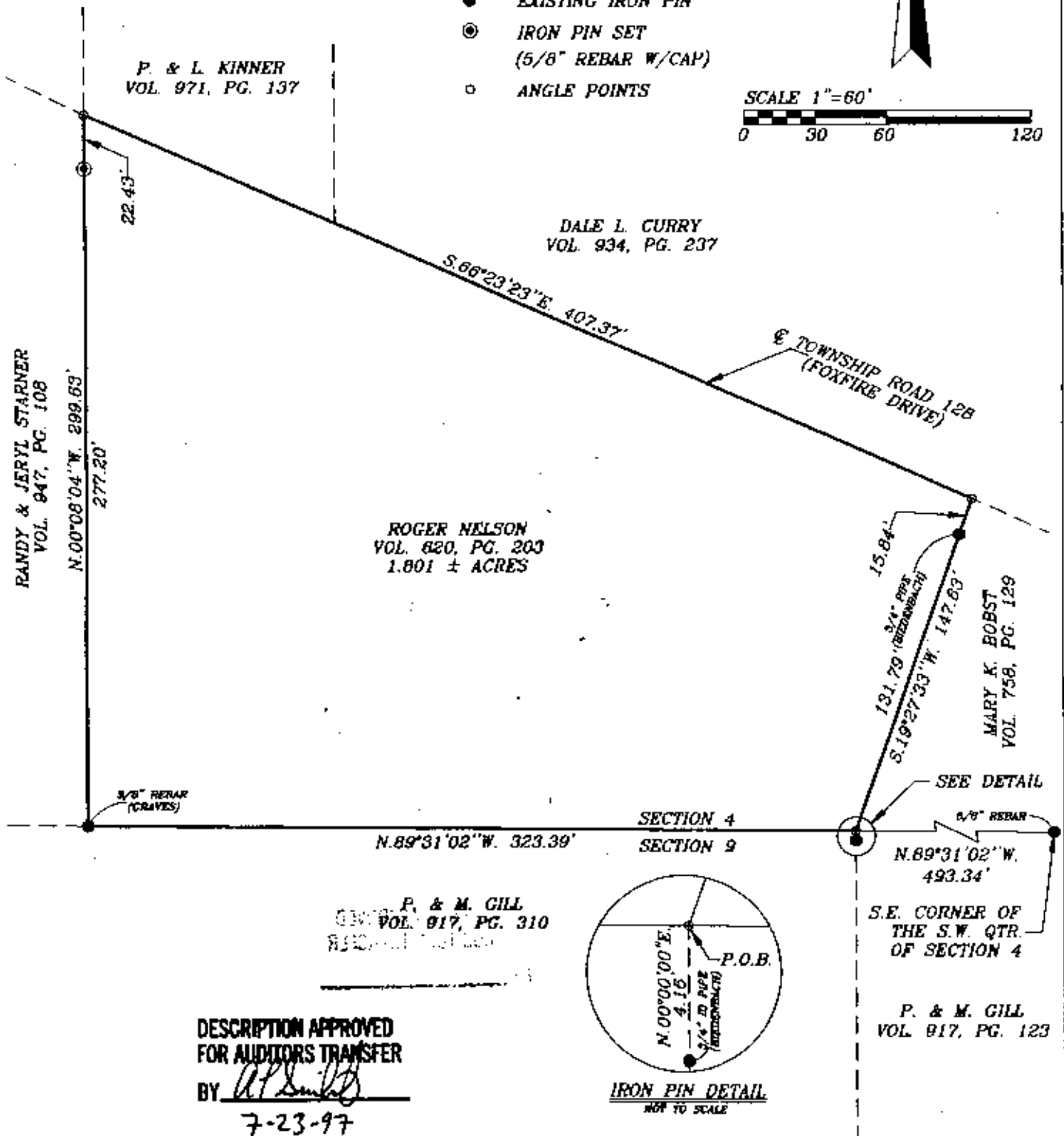
