

MEADOW FARM UNITED CHURCH

Situated in the State of Ohio, County of Muskingum, Newton Township, Part of the Southwest Quarter of Section 3, Township 15, Range 14. Bounded and described as follows:

Being all of Meadow Farm United Church Volume 762, page 57. Parcel No. 47-12-01-15-000.

Commencing at the Southwest corner of the Southwest Quarter of section 3; Thence North $0^{\circ}43'29''$ West along west line of the Southwest Quarter of Section 3, 1273.30' feet to a point in Thompson Run Road, being the Place of Beginning; Thence continuing North $0^{\circ}43'29''$ West 203.37' feet to a point in Thompson Run Road; Thence leaving said road and along Mark Dement Volume 768, page 150, North $78^{\circ}25'10''$ East 228.76' feet to a iron pin found, passing a iron pin found at 10.65' feet; Thence South $0^{\circ}13'21''$ West along Delbert & Miriam Cornett Volume 821, page 325, 277.65' feet to a iron pin found; Thence North $82^{\circ}40'00''$ West along Michael Bauserman O.R. Volume 1719, page 442, 222.27' feet to the Place of Beginning, passing a iron pin found at 210.94' feet. Containing 1.23 Acres more or less.

Bearings are based on the West line of the Southwest Quarter of Section 3 , Bearing North $0^{\circ}43'29''$ West.

Iron pins set are No. 5 reinforced bars 30" inches long with plastic I.D. caps " RLS 5410".

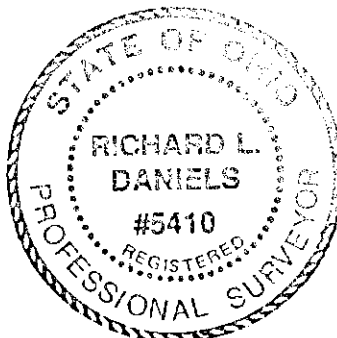

of Section 3, Township 15, Range 14.

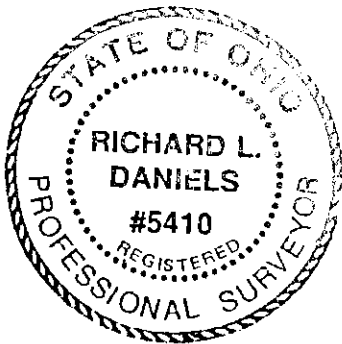
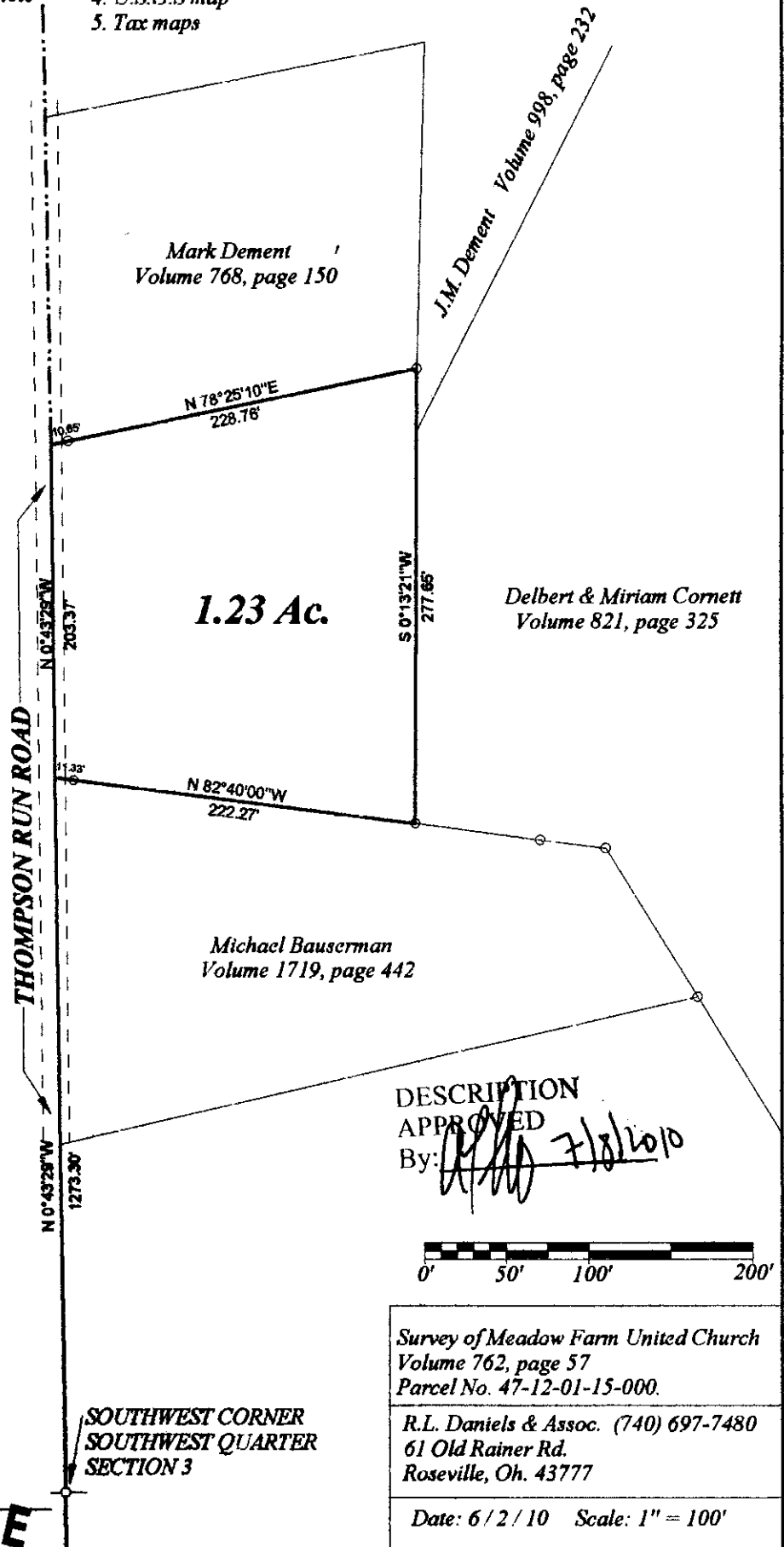


Basis of Bearings
