

DESCRIPTION OF SURVEY FOR SHIRLEY STADLER

Situated in the State of Ohio, County of Muskingum, Township of Newton:

Being part of the Southeast Quarter, Section 3, Township 15, Range 14, of the Congress lands East of the Scioto River, further **being all of** the Shirley Stadler property recorded in **Official Record Volume 2280, Page 86** of said county's deed records, further **being all of** Muskingum County Auditor's **Parcel Number 47-13-03-01-000**, and more particularly described as follows;

Commencing at a stone (found) at the Center of Section 3, also being on the line between Newton and Springfield Townships of Muskingum County;

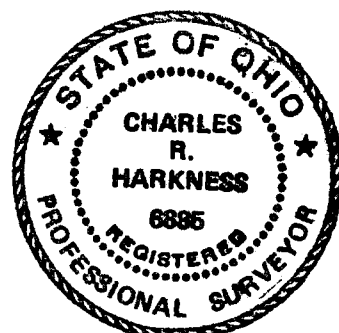
- TIE- THENCE South 87 degrees 02 minutes 48 seconds East 674.54 feet** along said Township line and common line for the Northeast and Southeast Quarters of Section 3, to an iron pin (set) at a common corner for said Stadler property and for the Lexa J Freshly property recorded in Official Record Volume 1622, Page 306, further being the place of beginning for the property herein intended to be described, passing an iron pin (found) at 224.54 feet;
- #1- THENCE South 87 degrees 02 minutes 48 seconds East 295.43 feet** continuing along said Township line and Quarter Section line to an iron pin (set) at a common corner for said Stadler property and for the Delbert A Cornett and Miriam Cornett property recorded in Official Record Volume 2243, Page 902, passing an iron pin (found) at 143.09 feet being a common corner for the Ida K Cooper and Jane L Cooper property recorded in Official Record Volume 2441, Page 356 (located in Springfield Township) and for the Terry L Hittle and Julie A Hittle property recorded in Deed Book Volume 1064, Page 265 (located in Springfield Township);
- #2- THENCE South 30 degrees 21 minutes 35 seconds West 188.88 feet** into the Southeast Quarter and along the common line for said Stadler and Cornett properties to an unmarked point in the centerline of Foxfire Drive and a common corner for said Stadler property and for the Cris Sidwell property recorded in Official record Volume 2227, Page 671;
- #3- THENCE North 88 degrees 18 minutes 44 seconds West 204.74 feet** leaving said road and along said Stadler and Sidwell properties to an iron pin (found) at a common corner for said Stadler, Freshly, and Sidwell properties, passing an iron pin (found) at 30.00 feet;
- #4- THENCE North 01 degrees 41 minutes 16 seconds East 172.24 feet** along the common line for said Stadler and Freshly properties to the place of beginning, **containing 0.97 acres**, of which 0.07 acres are within the right of way of Foxfire Drive.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

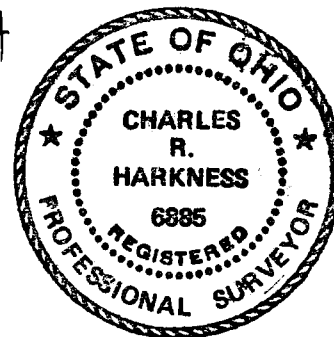
