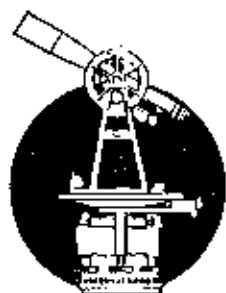

Beginning at an iron pin found at the Southeast corner of the Southwest Quarter of said Section 2; thence along the south line of said Section 2 north 84 degrees 40 minutes 46 seconds west 641 feet to an iron pin found; thence north 5 degrees 00 minutes 04 seconds east 1831.67 feet to a point; thence north 45 degrees 57 minutes 51 seconds east 136.37 feet to an iron pin found; thence north 44 degrees 17 minutes 09 seconds west 174.34 feet to an iron pin found on the east right of way line of State Route #22; thence along said right of way line north 46 degrees 04 minutes east 65.03 feet to a concrete monument found; thence south 5 degrees 00 minutes 04 seconds west 15.22 feet to an iron pin found; thence north 46 degrees 04 minutes east 26.49 feet to an iron pin found; thence leaving said right of way south 44 degrees 11 minutes east 357.70 feet to an iron pin found; thence south 45 degrees 49 minutes west 65 feet to an iron pin; thence south 44 degrees 11 minutes east 295 feet to an iron pin; thence north 45 degrees 49 minutes east 65 feet to an iron pin; thence south 44 degrees 11 minutes east 140 feet to an iron pin; thence north 68 degrees 16 minutes east 344.39 feet to an iron pin; thence south 83 degrees 59 minutes 48 seconds east 1346.79 feet to an iron pin found; thence south 5 degrees 40 minutes 17 seconds west 77.53 feet to a point in the center of Shaw Road; thence along the center of Shaw Road the following four (4) courses and distances, south 30 degrees 55 minutes 55 seconds west 254.58 feet to a point; thence south 50 degrees 01 minutes 53 seconds west 700.18 feet to a point; thence south 39 degrees 55 minutes 33

seconds west 314.68 feet to a point; thence south 28 degrees 49 minutes 19 seconds west 172.40 feet to a point; thence leaving said centerline north 85 degrees 08 minutes 27 seconds west 771.0 feet to a 2" pipe found; thence south 5 degrees 14 minutes 20 seconds west 500.02 feet to the place of beginning, containing sixty and sixty-six hundredths (60.66) acres more or less.

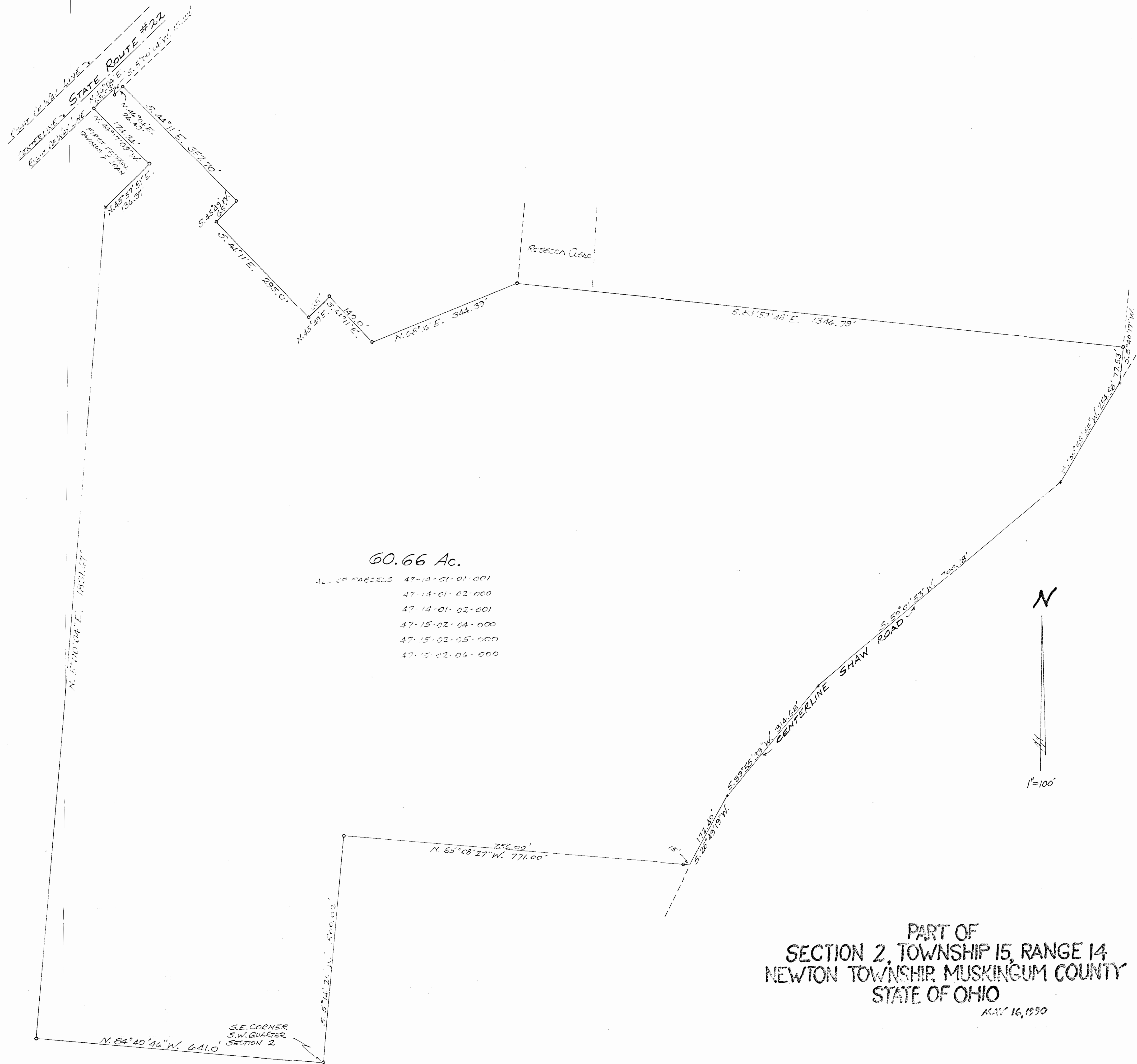
