DESCRIPTION OF SURVEY FOR ENKEN INC.

Situated in the State of Ohio, County of Muskingum, Township of Newton, Southwest Quarter of Section #2, Township #15, Range #14, of the Congress Lands East of the Scioto River:

Being all of the prior deed reference Vol. 755, Page 141. The Muskingum County Auditor's Parcel Number for the property is #47-47-14-01-05-000 and more particularly described as follows;

Commencing at the Northeast corner of said Southwest Quarter of Section #2; thence (by deed) N $43^{\circ} 30'$ W 189.60 feet to the center line of US Route #22 (Maysville Pike) Old Location; thence along the center line of said US Route #22 (by deed) S $46^{\circ} 44'$ W 1,241.26 feet to the place of beginning for the property herein intended to be described; thence along the Southwest line of the property described in deed reference Vol. 412, Page 610 S $43^{\circ} 24' 57''$ E 78.90 feet to an iron pin (set) on the Southeast right-of-way of the Existing Route #22, being 50.00 feet right of Station 414+99.30 of the Center line of existing US Route #22 as shown on the Center line plat and recorded in Plat Book 9, Page 4, of said County's records; thence continuing along the Southwest line of said Vol. 412, Page 610 S $43^{\circ} 24' 57''$ E 326.89 feet to an axle (found) at the Southeast corner of said Vol. 412, Page 610; thence S $05^{\circ} 20' 28''$ W 49.24 feet to an axle (found); thence S $46^{\circ} 42' 54''$ W 162.90 feet to an iron pin (set); thence N $43^{\circ} 25' 32''$ W 359.50 feet to an axle (found) on the Southeast right-of-way line for said Existing US Route #22, being 50.00 feet right of Station 412+99.30 of said Center line Plat; thence N $43^{\circ} 25' 32''$ W 78.90 feet to the center line of said US Route #22 Old Location; thence along the center line of said Old Location N $46^{\circ} 44' 00''$ E 200.00 feet to the place of beginning, containing 1.998 acres.

The bearings in this description are based on the Southeasteren right-of-way of US Route #22 as described in the prior deed reference Vol. 755, Page 141. Iron pins (set) are 5/8" rebar 34" in length with aluminum identification caps (C R Harkness R S 6885).

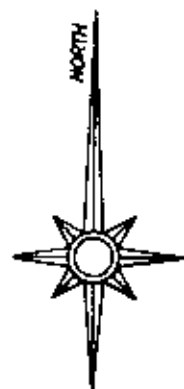

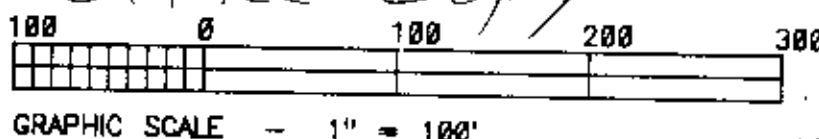

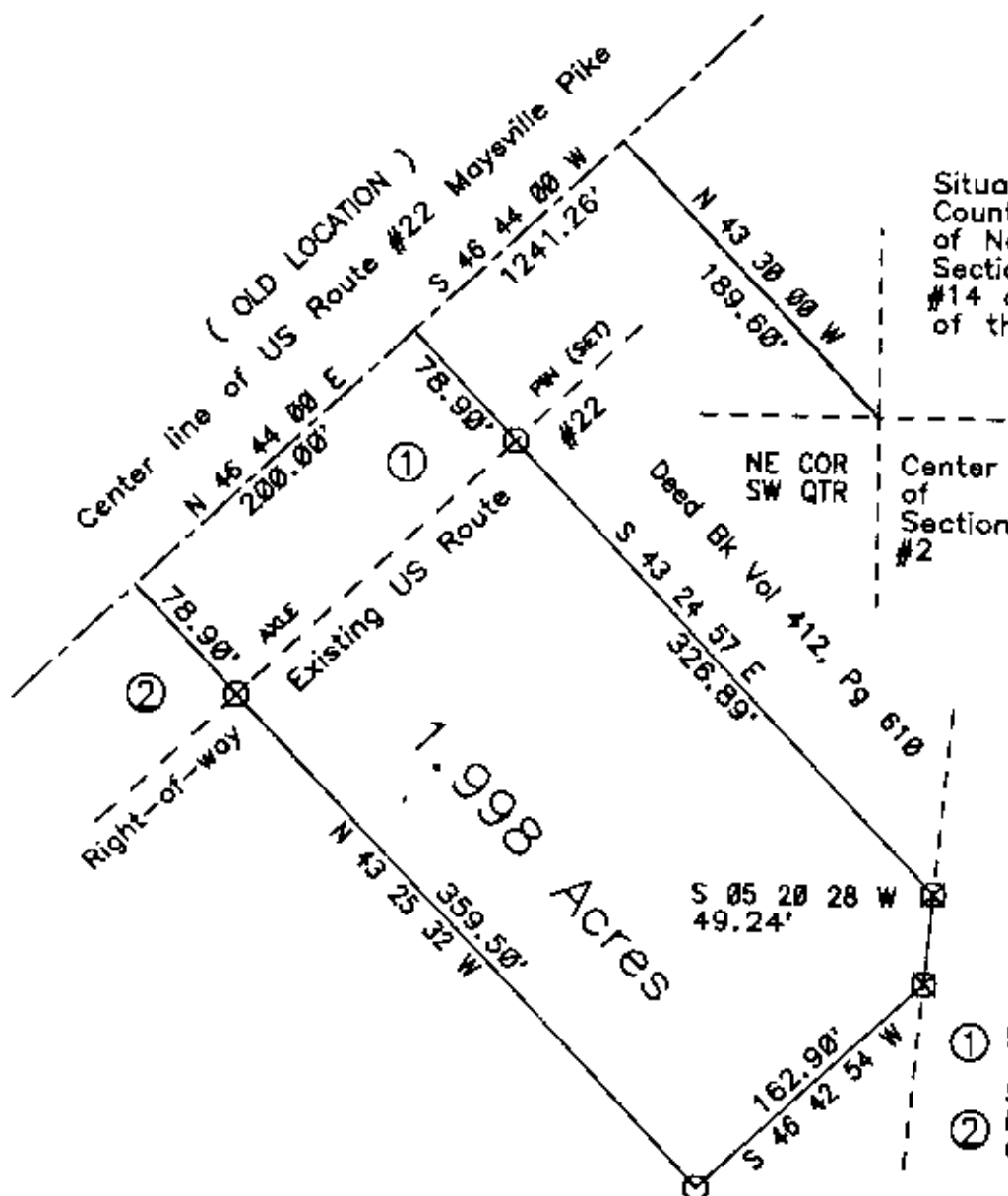
